To whom it may concern,

I would like to share this additional video for the RIVCO BoS to watch at their leisure, due to time constraints and the ability to share this additional information during the RIVCO BoS Public hearing.

The purpose of this second video is to just show some additional footage of vehicles having to do four to six point turns or back up the whole length of Cibola Circle, which is a daily event on Cibola Circle that is captured on my cameras (continuous recording, not motion activated) throughout my property or by me using a cell phone to document it.

In this video, besides the examples of vehicles having issues turning around on Cibola Circle, there is a clip that shows Mike Noel having to come down to Alta Mesa to pick up a delivery. The reason was because the delivery truck driver did not want to back up the whole 650' length of Cibola Circle.

However, you can hear the conversation in this clip where Mike Noel tells the driver that he (Noel) would have opened his gate up so he could turn around in his driveway. The part of the land that was given away during the vacation of Caravel Lane that could have been used for a public turnabout vs one on private land that the Public has no access to.

The RIVCO Director of Transportation (Mark Landcaster) said a turnabout was not need for Cibola Circle, despite the fact that it is a 650' long, less than 30' wide road, dead-end road, with no turnabout or fire hydrant.

I also want to point out that Lancaster called Caravel Lane, that was supposed to be a 30' wide road, as only a half a road that would only allow for one-way traffic. Think about that, if that is the case, does that mean Cibola Circle is only half a road that will only allow for one-way traffic. So then why not at least require as a minimum a turnabout at the dead-end portion of the road and a turnout midway? Bottomline, we know that isn't the case, but it was a misrepresentation that Lancaster present to the RIVCO BoS to further the agenda of vacating Caravel Lane.

Again, this is just some addition information that I want to present to the RIVCO BoS that I could not present due to time constraints during the RIVCO BoS meeting. I will continue to come to the RIVCO BoS to present how the handling of the vacation of Caravel Lane was mishandled by some RIVCO employees, Sr. RIVCO employees and Sr. Public Servants despite the small evidence that has been presented thus far.

I want to note that we have given RIVCO officials the opportunity to request the additional information or facts that we have freely, because we told the RIVCO officials this is not even a fraction of what we have.

We also informed RIVCO officials during our talks to them about how was easily verifiable the facts are, or we could provide them with the additional information/evidence to support our claims. No one has asked for it or requested it, instead the answer we got was if it was needed, they would contact us via our attorney for it.

The end results as you all know was the Vacation of Caravel Lane. However, as I have pointed out in just in Lancaster's comments and presentation during that hearing for the vacation of Caravel Lane to the RIVCO BoS was not factually accurate, filled with disinformation or misleading, which resulted in a FREE GIFT of PUBLIC LAND to a RIVCO PUBLIC SERVANT (Megan Kavand, a RIVCO Senior Financial Analyst) and her family (the property owner Mike Noel and other family members that reside of the property).

In future Public BoS Public hearing I will be presenting more hard facts about the Planning Commission and other RIVCO agencies that worked together to push the vacation of Caravel Lane through and how they played a part in the mishandling of the vacation of Caravel Lane, which resulted in a FREE GIFT of PUBLIC LAND to a RIVCO PUBLIC SERVANT and their family.

The RIVCO BoS has the opportunity to fix this issue if they choose and hold those accountable that violated their trust as RIVCO public officials in the handling of the vacation of Caravel Lane. Lastly, I want to take the time to say thank you, to the RIVCO BoS that did take the time to look at this additional information and read my email. V/R and best, Chuck
