BACKGROUND:

Summary

On March 4, 2020, Governor Gavin Newsom proclaimed a State of Emergency in the State of California because of the novel Coronavirus 2019 (COVID-19) and issued additional declarations and executive orders due to the ongoing nature of the emergency. As per the Director of Emergency Services Emergency Procurement Order dated March 26, 2020, the competitive bidding process was suspended for necessary goods and services immediately needed in the County of Riverside's operations for the preservation of life and property during the existence of a Local Emergency in the County of Riverside regarding COVID-19.

During emergencies the Office on Aging department works to ensure vulnerable communities within the county receive needed services for safety and resilience and as a result of the COVID-19 emergency, on April 5, 2021, Office of Aging entered into a Professional Service Agreement with Special Service for Groups, Inc. for outreach and linkage services for isolated Asian Pacific Islander (API) older adults for a period of January 1, 2021 through September 30, 2021. These services are 100% federally funded by the COVID Cares Act Fund.

Special Service for Groups, Inc., through its affiliate Asian Pacific Counseling and Treatment Centers, provides Older Americans Act Title III B Outreach, Title III B Material Aid, and Title III E Family Caregiver Support services to isolated older adults and disabled persons within the API community.

This Amendment No. 1 to the Professional Services Agreement before the Board seeks to extend the period of performance from September 30, 2021 out through November 30, 2021 and replace the prior Exhibit B: Payment Provisions in order to reallocate funds among existing service type line items.

Impact on Residents and Businesses

Outreach and linkage services for isolated Asian Pacific Islander older adults is instrumental and will aid with the resilience of County communities.

This Amendment No 1. extends the period of performance and reallocates the original contract funds among existing services type items only. No additional funds are required. The original contract amount of \$100,000 was 100% funded by the COVID CARES Act.

Contract History and Price Reasonableness

The requested service was initiated as a result of the COVID-19 pandemic. As per the Director of Emergency Services Emergency Procurement Order dated March 26, 2020, the competitive bidding process was suspended for necessary goods and services immediately needed in the County of Riverside's operations for the preservation of life and property during the existence of a Local Emergency in the County of Riverside regarding COVID-19. As such, the original Professional Service Agreement with Special Service for Groups, Inc. for COVID-19 Outreach and Linkage Services for Isolated API Older Adults was executed in the amount of \$100,000 covering the period of January 1, 2021 through September 30, 2021.

This Amendment No 1 (Purchasing Approved SSJ# 152284497) seeks Board approval due to the rescinding of the Emergency Procurement Order on May 12, 2021 and this amendment extending the contract period performance out through November 30, 2021.


