BACKGROUND:

Summary 3 1

The Riverside County Housing Navigators Program (HNP) has received an additional funding allocation issued by the California Department of Housing and Community Development (HCD) in the amount of \$223,940. These additional funds must be expended by June 30, 2024.

The Board initially adopted Resolution No. 2020-085 to accept HNP funding allocation for DPSS in the amount of \$223,940 on May 12, 2020 (Agenda Item 3.5). This funding is to be expended by June 30, 2022. An additional allocation of \$19,266 was received from HCD and accepted by way of Resolution No. 2021-071 on May 11, 2021 (Agenda Item 3.20). This funding is to be expended by June 30, 2023.

This funding is used for housing navigators to act as housing specialists to assist young adults between the ages of 18-21 to secure and maintain housing. Priority is given to young adults in foster care. The funding will also assist with case management, preventative measures to protect youth from homelessness and assist youth with linkages to community resources. Approximately 80 young adults were served in the previous year and 80 to 100 young adults are targeted for this new funding.

Impact on Residents and Businesses

This funding will ensure that young adults between the ages of 18 to 21 secure and maintain safe and stable housing.

Additional Fiscal Information

The Housing Navigators Program is 100% funded through State funds.



18	as amended by Section 16 of Chapter 363 of the Statutes of 2019 (SB 109); and
19	WHEREAS, the HNP additional allocation relates to funding to county child welfare
20	agencies for the provision of housing navigators services to help young adults aged 18 years and up to 21
21	years secure and maintain housing, with priority given to young adults in the foster care system; and
22	WHEREAS, the County of Riverside, Department of Public Social Services ("DPSS" or
23	"Applicant"), is the allocation applicant required to submit the HNP Allocation Acceptance form, and other
24	documentation, on behalf of the County in order to accept and receive an allocation; and
25	WHEREAS, the HNP County Allocation award will be used by DPSS to provide housing
26	navigators to act as housing specialists to assist young adults in overcoming barriers to housing.

SECTION 1. That the Director of DPSS, or designee, is hereby authorized to accept the
Housing Navigators Program County Additional Allocation award by the State of California, Department
of Housing and Community Development, on behalf of the County, as detailed in its HNP Allocation
Acceptance form in the amount of \$223,940 or other amount as authorized by the Department under
applicable state law.

9 SECTION 2. That the Director of DPSS, or designee, is hereby authorized to act on behalf
10 of the County in connection with the HNP Allocation award, and to enter into, execute, and deliver the
11 standard agreement, forms, and any and all documents required by the State or deemed necessary or
12 appropriate to be awarded the HNP County Allocation award and future HNP County Allocation, including
13 subsequent amendments or modifications thereto (collectively, the "Housing Navigator Program Allocation

 in the Housing Navigator Program Allocation Documents, and that Applicant will use the HNP County
 Allocation award funds in accordance with the HNP Allocation Acceptance form, the HNP Allocation
 Award Documents, and any and all HNP requirements or other applicable rules and laws.
