BACKGROUND:

<u>Summary</u>

Transitional Housing Program (THP) services help young adults who are 18 to 25 years of age to secure and maintain housing by reducing the waitlist for housing and providing linkage to community services for emancipated young adults. The Riverside County Department of Public Social Services (DPSS) is currently providing Transitional Housing Program-Plus (THP-Plus) services to a caseload of 41 emancipated young adults.

The Board of Supervisors previously approved the first round of THP funding in the amount of \$257,600 (for FY 19/20) from the California Department of Housing and Community Development (HCD) to DPSS at the May 19, 2020 Board meeting (Agenda Item No. 3.27). And a second round of funding in the amount of \$257,600 approved at the October 27, 2020 Board of Supervisors meeting (Agenda Item 3.14). The HCD has allocated a third round of funding in the amount of \$257,600 to DPSS for THP services. DPSS has two years to spend each allocation. With the prior funding from HCD, DPSS was able to increase the number of young adults served and add an additional part-time life coach to assist former foster youth in securing and maintaining housing, while they seek employment, education, or other self-sufficiency sustaining tasks.

Impact on Residents and Businesses

THP services funding will ensure that housing and other self-sufficiency services are available for young adults between the ages of 18 to 25.

Additional Fiscal Information

This third round of THP funding must be expended by June 30, 2024. No General Fund match is required for receipt of these funds.


