BACKGROUND:

Summary

The Sheriff's Department currently services the unincorporated communities of Home Gardens, Coronita, Lake Hills, Woodcrest, El Cerrito, Temescal Valley, Lake Mathews, and Gavilan Hills. The Sheriff's Department does not have a Sheriff facility in this region and utilizes deputy sheriffs from three neighboring stations to provide services to the region from an extended distance of travel.

The Sheriff's Department intends to move toward its goal of increasing services to the communities in this region by opening a Sheriff's Station within this geographical area. The Sheriff's Department therefore proposes initiation of a search for potential sites to lease within the listed geographical area which will more efficiently service the needs of the citizens within these communities. Facilities Management concurs that there is no suitable county-owned space available for occupancy in this area. The department would consider a full range of available buildings in the community. The facility estimate is approximately 19,000 square feet, capable of accommodating 70 staff members, secure parking area, and requiring tenant improvements only.

Impact on Residents and Businesses

The new desired location should be conveniently located within reasonable driving distance of the unincorporated area of District 1 and District 2.
