#### BACKGROUND:

#### Summary

Since 1972, Valley-Wide Recreation and Park District (Valley-Wide) has served as the primary provider of recreational services for the 800-square-mile area encompassing Hemet, San Jacinto, Valle Vista, Sage, Aguanga, Winchester, Menifee, and French Valley. Valley-Wide has prepared, adopted, and submitted for approval by the County its updated Master Plan, which will be used to plan and direct park and recreation services within its service area. This includes the facilitation of leisure opportunities through partnerships with private and public agencies and entities to ensure that members of the public receive personal benefits such as physical fitness, relaxation and revitalization; social benefits in the form of stronger and healthier families and enrichment for persons with disabilities as well as economic benefits through more productive and healthier citizens and increased tourism.

The updated Master Plan will also serve as a basis for the collection of park fees and land dedications pursuant to the Quimby Act as enacted locally by Ordinance No. 460. Valley-Wide Recreation and Park District's 2020 Master Plan update is an independent planning document for the District. Riverside County Ordinance No. 460 requires Board of Supervisors approval of the Master Plan solely for the purpose of enabling Valley-Wide to provide park facilities within the unincorporated territory of the County that is within Valley-Wide's jurisdiction, in accordance with the Master Plan.

Section 10.35 of Riverside County Ordinance No. 460 requires that the County give public notice and conduct a public hearing prior to the approval and adoption of a Master Plan. This public hearing was set by the Board of Supervisors on December 14, 2021 as item 3.52.

#### Impact on Residents and Businesses

The residents of Riverside County will benefit from this Master Plan which will be used to plan and provide park and recreation services within the Valley-Wide Recreation and Park District service area on a community wide level.

## RE: ARMANDO VILLA'S / CITY OF MENIFEE'S JANUARY 6TH REQUEST TO DELAY THE PUBLIC HEARING REGARDING VALLEY-WIDE RECREATION AND PARK DISTRICT MASTER PLAN

Dear Board of Supervisors:

Thank you so much for your service during these quite trying times.

Mr. Villa's January 6<sup>th</sup> letter indicated that 291 surveys were received from residents throughout the entire area of Valley-Wide's jurisdiction, 12% of which were from Menifee residents. This, to me, is an indication that the surveys were available for Menifee residents to complete in the exact same way that they were made available to the residents of all of the other communities served by Valley-Wide. Consequently, I would like to emphasize the following:

- The collective choices constituents make regarding the completion and submittal of surveys is not a valid justification for the Master Plan public hearings to be further delayed.
- The fact that Menifee residents have roughly half of Valley-Wide's park acreage is an indicator of the relative level of services provided to the residents of Menifee, within Valley Wide's overall service area, not a justification to delay taking action on the Master Plan.

Mr. Villa indicated in his letter that "The City has raised questions about increased levies and assessments". However, **Mr. Villa omitted the names of those to whom have these questions been raised.** Valley-Wide's fourth division encompasses nearly all of our Menifee areas of service. In my capacity as a Director, I am in frequent contact with Valley-Wide's G.M. and

other staff. Neither the Board of Directors or staff received any questions from the residents or City of Menifee staff regarding the Master Plan, which has been on the Board agenda three times (June 15, 2020, June 21, 2021 and November 15, 2021). Moreover, the Valley-Wide Recreation Board of Directors originally adopted the Master Plan on June 15, <u>2020</u>.

If Menifee staff or residents have questions or concerns about their current or future tax rates, or levels of service, they should raise them either at the public hearing for the Master Plan, or more aptly, directly with the General Manager, so that those questions can be addressed by staff. Delaying the public hearing only delays the opportunity for the public to speak in response to the proposed Master Plan, and the rejection, revision, or adoption of the Master Plan by the County Board of Supervisors.

As for Mr. Villa's observation that no Menifee residents serve on Valley Wide's Board of Directors, I ask that the Board make note of the fact that **no Menifee residents applied to run** for the Division Four seat on the Board of Directors when that seat came up for re-election in 2020.

With all due respect to Mr. Villa and his role within the City of Menifee, I respectfully request that you conduct the public hearing as scheduled on January 25th. All of us, including Mr. Villa, have had since June 2020 to make any concerns known regarding the Master Plan. Unless your Board has cause to remove Valley-Wide as the park provider in its current area of jurisdiction, I request that you take action to approve the Master Plan as put forth by staff during your January 25<sup>th</sup> meeting.
