On motion of Supervisor Hewitt, seconded by Supervisor Washington, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, January 25, 2022, be adjourned in memory of Lulamae Clemons who passed at the age of 105 years old.

Lulamae Clemons and her family moved to Pueblo, Colorado, so she could attend a non-segregated school. Clemons graduated high school in Pueblo and was one of its first 13 black students.

Lulemae Clemons moved to Riverside in 1956 and earned a master's and a doctorate from USC. She worked as a health-education consultant, becoming on of the first Black administrators hired by Riverside County Office of Education. Lulemae was a civil rights leader throughout the County of Riverside. She was vital in the movement to build a statue of Dr. Martin Luther King Jr. in downtown Riverside.

Lulemae Clemons spoke in favor of naming Riverside's King High School in the 1990's and helped get the Grier Pavilion built at Riverside City Hall, which was named after civil rights activists Barnett and Elanor Jean Grier. She was a past president of the Riverside chapter of the NAACP, she led its Head Start program, and was the first chairperson of Riverside's Community Relations Commission.

Lulemae Clemons was Vice President of the Fair Housing Council of Riverside County, where she fought for equal housing rights for African Americans and received a lifetime achievement award.

Lulemae Clemons was inducted into UC Riverside Women's Hall of Fame in 1999, named Citizen of the Year by the Greater Riverside Chambers of Commerce in 2002, and was recognized by the Riverside African American Historical Society for her decades of service.

Lulamae Clemons' memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be greatly missed but never forgotten.
