## BACKGROUND:

### <u>Summary</u>

The County of Riverside Department of Public Health-Injury Prevention Services (IPS) received funding from the Office of Traffic Safety (OTS) to provide education and resources to local college campuses in an effort to reduce the number of residents killed or injured due to alcohol-impaired, drug-impaired, and distracted driving. The program will include collaborating with community and advocacy groups in providing training for peer educators and students on the dangers of impaired and distracted driving. Public Health will engage and support college law enforcement departments in impaired and distracted driving awareness activities and conducting outreach events on each campus by utilizing the OTS Go Safely campaign messaging on all participating campuses.

## Impact on Residents and Businesses

Program will benefit County Residents by helping reduce the number of residents killed or injured due to impaired and distracted driving.

### 1. PROBLEM STATEMENT

College beholds a pivotal time for young adults. During this transitional period from high school to entering college, being free of their parental influences and into an abundance of freedom some may struggle with finding acceptance from their new college peers. The promise of new experiences, building friendships and newfound autonomy, experimenting in new hobbies can be exciting, but with many new experiences, new challenges will also become apparent. One such challenge that has posed problematic for college administrators, law enforcement, and health educators is the prevalence of impaired and distracted driving. College students and adults face one of the highest risks for fatal crashes involving distracted and impaired driving. (Attachment A) The most abused substance on college campuses is alcohol, the National Institute on Alcohol Abuse and Alcoholism reports that four out of five college students drink alcohol. (Attachment B). According to the 2018 National Survey on Drug Use and Health (NSDUH), in 2018, 20.5 million people aged 16 or older drove under the influence of alcohol in the past year and 12.6 million drove under the influence of illicit drugs. In addition, after alcohol, marijuana is the drug most often found in the blood of drivers involved in crashes. (Attachment C) Many factors can be considered when it comes to alcohol and drug abuse in colleges. Factors such as social influences, protective factors, social and educational stress, living situations, mental health, etc. (Attachment D) in 2018, over 2,800 people died, and an estimated 400,000 people were injured due to distracted driving.

Previous and current research shows and solidifies that there are clear public health concerns regarding impaired and distracted driving within our college communities. In an annual survey, results show that approximately 46% of college students drive a car. In addition, research estimates that each year 1,825 college students between the ages of 18 and 24 die due to alcohol-related unintentional injuries. In 2018, 20.5 million people aged 16 or older drove under the influence of alcohol in the past year and 12.6 million drove under the influence of illicit drugs. Despite most college campuses having rules and regulations when it comes to alcohol and drug consumption, in many instances there is a failure to enforce these campus policies.

In 2017, California did not have a day without a traffic fatality. The 2017 Annual Report of Fatal and Injury Motor Vehicle Traffic Crashes Report found there was a 4.4 percent increase in alcohol involved fatal crashes. Persons killed when alcohol was involved also increased 5.8 percent over the previous year. In addition, 1,167 people died in alcohol involved crashes and 18,569 people were injured in 2017. (Attachment I) Furthermore, the California Department of Motor Vehicles (DMV) 2017 report indicates that 141,373 arrest were made for driving under the influence (DUI) were made statewide, slightly over 49% (69,868) occurring among drivers age 30 years and younger. (Attachment J) According to the 2017 National Highway Traffic Safety studies, the highest percentage of drunk drivers was for drivers age 21 to 24 (27 percent), followed by ages 25 to 34 (26 percent). (Attachment K) As DUI enforcement is a grand focus within the law enforcement system, it is important to intertwine with law enforcement and public health to provide an effective system that will ultimately change the perception and actions of county residents. Through the method of public education, outreach and awareness strategies, the means of an effective approach can come to fruition.

Analyzing the issue of drunk, drugged, and distracted driving in Riverside County (RC), many similar challenges are apparent. With over 7,200 square miles, RC is a diverse area of suburban and rural communities. Riverside County (RC) is currently divided by two main highways (I-15 and I-10), and two main freeways (R-91 and R-60) stretching 200 miles. Current census data estimates RC population at 2.47 million with 24% between 18-34 years of age. According to the 2017 Annual Report of Fatal and Injury Motor Vehicle Traffic Crashes, Riverside County (RC) ranked among the top five number of fatalities due to alcohol involved crashes. Alcohol impaired collision data for RC shows that 1161 fatal/injured collisions occurred in 2019. Of these, 1,017 stemmed from drivers between 18-34 years of age. Again, subsequent years have failed to show improvement.

According to the Federal Bureau of Investigation, in 2018, over 1 million people were arrested for driving under the influence of drugs or drugs. (Attachment N) The cost of impaired driving crashes has cost over \$44 billion. In a ten-year period, alcohol and drug impaired driving has cost over 10,000 lives in California.

- Obtain commitment from six (6) college campuses to participate in the College Communities Against Drunk, Drugged and Distracted Driving program.
- Identify a liaison and peer health educators at each college campus that will communicate with RUHS-PH on all program activities.
- To obtain commitment from each campus law enforcement to participate in outreach events focusing on impaired and distracted driving.
- Create a master calendar that schedules all awareness activities.
- Update Injury Prevention Services website listing new traffic safety program activities.
- Identify media outlets in Riverside County.
- Develop a filing system to monitor all grant activities to ensure adequate reporting to funding source.
- Develop a data base to capture all demographic/statistical information and track objective progress relevant to grant activities.
- Purchase all necessary educational materials conduct grant related activities.
- Reproduce OTS Go Safely Campaign material for dissemination at participating community college campuses.

#### Media Requirements

 Issue a press release approved by the OTS PIO announcing the kick-off of the grant by November 15, but no sooner than October 1. The kick-off release must be approved by the OTS PIO and only distributed after the grant is fully signed and executed. If you are unable to meet the November 15 deadline to issue a kick-off press release, communicate reasons to your OTS coordinator and OTS PIO.

### B. <u>Phase 2 – Program Operations</u> (Throughout Grant Year)

- Utilizing peer health educators
- Establish an alcohol, drug impaired and distracted driving program at six (6) college campuses in Riverside County.
- Conduct a minimum of twelve (12) on campus campaigns/activities collaborating with campus law enforcement, peer health educators and community agencies to address impaired and distracted driving.
- Conduct six (6) social media campaigns on distracted and impaired driving.
- Disseminate twelve (12) newsletters at participating college campuses.
- Compile all evaluations forms from the student trainings.
- Maintain all demographic and statistical data related to grant activities.

#### Media Reguirements

- Send all media advisories, alerts, videos, graphics, artwork, posters, radio/PSA/video scripts, storyboards, digital and/or print educational materials for grant-related activities to the OTS PIO at pio@ots.ca.gov for approval and copy your OTS coordinator. - The OTS PIO is responsible for the approval of the design and content of materials. The agency
  understands OTS PIO approval is not authorizing approval of budget expenditure or cost. Any
  cost approvals must come from the Coordinator.
- Pre-approval is not required when using any OTS-supplied template for media advisories, press
  releases, social media graphics, videos or posts, or any other OTS-supplied educational material.
  However, copy the OTS PIO at pio@ots.ca.gov and your OTS coordinator when any material is
  distributed to the media and public, such as a press release, educational material, or link to social
  media post. The OTS-supplied kick-off press release templates and any kickoff press releases
  are an exception to this policy and require prior approval before distribution to the media and
  public.
- If an OTS-supplied template, educational material, social media graphic, post or video is substantially changed, the changes shall be sent to the OTS PIO at pio@ots.ca.gov for approval and copy to your OTS Coordinator. Optimum lead time would be 7 days prior to the scheduled release date, but at least 3 business days prior to the scheduled release date for review and approval is appreciated.

#### POLICY ON BANNING TEXT MESSAGING WHILE DRIVING

In accordance with Executive Order 13513, Federal Leadership On Reducing Text Messaging While Driving, and DOT Order 3902.10, Text Messaging While Driving, States are encouraged to adopt and enforce workplace safety policies to decrease crashes caused by distracted driving, including policies to ban text messaging while driving company-owned or rented vehicles, Government-owned, leased or rented vehicles, or privately-owned vehicles when on official Government business or when performing any work on or behalf of the Government. States are also encouraged to conduct workplace safety initiatives in a manner commensurate with the size of the business, such as establishment of new rules and programs or re-evaluation of existing programs to prohibit text messaging while driving, and education, awareness, and other outreach to employees about the safety risks associated with texting while driving.
