Arvina was born November 10, 1934, in Turlock, California. She was the only child of Arvid Roland Klint and Agnes Valenta Klint. Arvina spent many hours in the local Carnegie library and attributed her lifelong love of reading to her loving parents. She took piano lessons throughout her elementary and high school years. After graduating from high school in 1952, Arvina attended Modesto Junior College for two years, before transferring to San Jose State, a teacher's college, to pursue her childhood dream of obtaining a college degree and becoming a kindergarten teacher. Teaching was Arvina's calling and passion.

Arvina relocated to Sacramento for a new teaching opportunity in 1963, and soon thereafter, met her future husband, Donald Lloyd Harriger. Arvina and Donald were married on July 13, 1968, at St. Ignatius Catholic Church in Sacramento. Soon thereafter, the couple relocated to Riverside, where they raised their family and resided for the past 52 years. Arvina was a devoted wife and mother, with a passion for motherhood that equaled her passion for teaching. She dedicated herself to creating a loving home for her husband and children.

Arvina supported and held many volunteer roles in the many activities of her children, including PTA executive board, and committee positions. She was a member of the Assistance League of Riverside, and the National Charity League. Arvina was a devout and active parishioner of St. Francis de Sales Catholic Church. She served as a coordinator for the Perpetual Eucharistic Adoration Society, and in 2019 she received an Award of Appreciation for the time devoted to parish ministries, including a continuous Novena to Our Lady of Perpetual Help.

Arvina was an avid reader of all types of literature, with a lifelong love of books, libraries, and bookstores. She also enjoyed doting on her five grandchildren, reconnecting with childhood friends, spending time with her close local friends, preparing and sending thoughtful messages on decorated greeting cards, reading her lovingly-worn Bible, and spending time with her Lord in prayer.

Arvina's memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be greatly missed but never forgotten.
