### BACKGROUND:

### <u>Summary</u>

The Riverside University Health System (RUHS) includes a 439-bed Medical Center in Moreno Valley, Community Health Centers (CHC), Correctional Health Systems (CHS), several primary and specialty clinics throughout Riverside County, and the Departments of Behavioral Health and Public Health. RUHS is comprised of approximately 6,000 team members, and has been the foundation of health care, community wellness, and medical education in Riverside for more than 100 years.

RUHS is currently utilizing Dental Assistants to provide chairside assistance to dentists and oral surgeons. Dental Assistants do not require licensure and are limited in their scope of practice, as defined by the California Dental Practice Act. However, as dental services continue to expand throughout RUHS - CHCs, it is essential to have proper staff available to perform a broader scope of dental services. A Registered Dental Assistant is licensed by the State of California and can perform a greater scope of practice (i.e.: chemically preparing teeth for bonding, polishing coronal surfaces of teeth, etc.), as outlined by the California Dental Practice Act. The addition of Registered Dental Assistants will allow RUHS to increase productivity and efficiency in providing dental services while following Health Resources and Services Administration (HRSA) guidelines.

An external market survey was conducted on the five surrounding counties (San Bernardino, Orange, Los Angeles, Ventura, and San Diego) for comparable positions to the Registered Dental Assistant job classification. The market results yielded that the Counties of Orange, San Bernardino, and Ventura have comparable classifications, while the Counties of Los Angeles and San Diego do not utilize Registered Dental Assistants. Based upon the external market survey, the salary range for the Registered Dental Assistant indicates \$41,863 - \$57,388 annually (Attachment 2).

### **Classification Addition:**

**Registered Dental Assistant**: It is recommended to add this classification to the Class and Salary Listing at salary plan/grade LIU 411 (\$41,863 - \$57,388/year). The new class specification is attached (**Attachment 3**).

Assistant classification will increase to productivity and efficiency, and allow for a broader scope of dental services.

#### Additional Fiscal Information

The creation of a Registered Dental Assistant job classification will have no immediate upfront costs to the Department. RUHS will add these position(s) to their budget at a later date. The cost to add one Registered Dental Assistant position is approximately \$83,212 per year, which includes salary and benefits. The Department has indicated that any future costs will be absorbed through the Department's budget and will not require a budget adjustment.

# **CLASS CONCEPT:**

Under close supervision, provides chairside assistance to dentists and oral surgeons; takes and processes x-rays; prepares instruments and patients for examinations and treatment; and performs other duties as assigned.

The Registered Dental Assistant is the advanced journey level classification and reports to a Healthcare Administrative Manager, Nurse Coordinator, or Dentist. Incumbents work under the technical guidance and supervision of a dentist or oral surgeon, and provides chairside assistance. The Registered Dental Assistant classification differs from the Dental Assistant classification in that the former is a licensed position with additional allowable duties as defined within the California Dental Practice Act.

A Pit and Fissure Sealants certificate must be obtained within 6 months from date of hire. Failure to obtain the Pit and Fissure Sealant certificate within the specified timeframe will result in incumbents either being returned to their former County job classification or new hires being released prior to the end of their initial probationary period.

### **REPRESENTATION UNIT:**

LIUNA – Inspections & Technical

#### **EXAMPLES OF ESSENTIAL DUTIES:**

(Depending on the area of assignment, duties may include, but are not limited to, the following)

• Assist dentists and oral surgeons by preparing and arranging dental instruments, equipment, and medication; prepare patients for treatment and examination; prepare local anesthetic syringes for the dentist.

• Take and process digital dental x-rays; mix impression materials; conduct pulp vitality testing and recording of findings; chemically prepare teeth for bonding; place bases, liners, and bonding agents; dry endodontically treated canals using absorbent paper points; polish coronal surfaces of the teeth; apply pit and fissure sealants; place post-extraction dressings after inspection of the surgical site by the supervising licensed dentist.

• Fabricate, adjust, cement, and remove indirect provisional restorations, including stainless steel crowns when used as a provisional restoration; place, adjust, and finish direct provisional restorations; remove excess cement from surfaces of teeth with a hand instrument.

· Clean and sterilize instruments; perform post-operative cleanup.

• Instruct patients in proper practices of dental hygiene; schedule appointments into the Patient Management Information System (PMIS), complete billing documents and data entry in the PMIS, and maintain dental records for all dental patients.

• Perform related duties and responsibilities as required and allowed by the California Dental Practice Act.

# **RECRUITING GUIDELINES:**

Education: Successful completion of the education required by the State of California to obtain the required valid license and certifications.

Experience: One year of providing chairside dental assistance to dentists and/or oral surgeons.

Knowledge of: Dental assistant procedures; principles and methods of sterilization; proper care and use of dental instruments, equipment, and materials.

Ability to: Take and process digital dental x-rays; learn basic operating room procedures necessary in oral surgery; comprehend and follow oral and written instructions; analyze situations accurately and adopt an effective course of action.

# **OTHER REQUIREMENTS:**

License/Certificate: Possession of a valid license as a Registered Dental Assistant issued by the California State Board of Dental examiners.

Possession of a valid Coronal Polishing certificate and Radiation Safety (X-Ray) certificate.

Possession of valid Basic Life Support (BLS) certificate issued by a provider certified by the American Heart Association.

Possession of a valid Pit and Fissure Sealants certificate must be obtained within 6 months from date of hire.

Possession of a valid California Driver's License may be required.

# **PRE-EMPLOYMENT:**

All employment offers are contingent upon successful completion of both a pre-employment physical exam, including a drug/alcohol test, and a criminal background investigation, which involves fingerprinting. (A felony or misdemeanor conviction may disqualify the applicant from County employment.)

# **PROBATIONARY PERIOD:**

As an Approved Local Merit System, all County of Riverside employees, except those serving "At Will," are subject to the probationary period provisions as specified in the applicable Memorandum of Understanding, County Resolution, or Salary Ordinance. Temporary and Per Diem employees serve at the pleasure of the agency/department head.
