C.E.O. RECOMMENDATION: Approve

BACKGROUND:

The Department of Animal Services (DAS) needs to replace vehicles that have exceeded their useful life. DAS has approximately sixty (60) vehicles that are used daily to support its mission. Fifty percent (50%) of the vehicles are over ten years old and each one holds a significant number of miles. In accordance with County Fleet's Equipment Life Cycle (LCCA) replacement guidelines, the average useful life for the type of vehicles being replaced is eight (8) years or 120,000 miles. Therefore, the department is beginning a vehicle replacement plan. The plan is to purchase eighteen (18) replacement vehicles to replace the vehicles older than ten (10) years old and purchase one (1) new vehicle to improve efficiency of the Community Cat Program specifically to transport felines.

Due to the current supply chain issue and the large number of vehicles being purchased which is a lengthy process, DAS is requesting for County Purchasing & Fleet to immediately begin the procurement process and issue purchase orders for the vehicles.

Below is a list of the vehicle types we plan purchase with an estimated amount of \$1,200,000.

5 EA: 3/4 Ton Animal Control Trucks

7 EA: 1/2 Ton 4x4 Trucks for Lieutenants and Sergeants

4 EA: 1/2 Ton Trucks

1 EA: Delivery Box Truck

2 EA: Cargo Vans

Impact on Residents and Businesses

The DAS mission is "Working Together to Improve Riverside County for People and Animals". Promoting an environment of responsible pet ownership through progressive animal welfare initiatives, community outreach, and humane education in a culture of compassion, creativity, and integrity makes a positive impact on our communities.

The replacement of older vehicles that have outlived their lifecycle is necessary to fulfill the DAS mission and to continue its operations effectively and without delay.

Additional Fiscal Information

There is no financial impact on the County's general fund. The additional funding for these vehicles in the Department's budget was generated by fees that were collected from higher than anticipated number of animal kenneling days and the recent increase in contract rates for "Contract Cities for Field, Shelter and Licensing" that were approved by the Board of Supervisors on June 8th, 2021, Item 3.4 (ID # 14893).

Contract History and Price Reasonableness

The County of Riverside Purchasing & Fleet Department issued RFQ PUARC-1650 for purchase of fleet vehicles. The bid was awarded to Winner Chevrolet and Fleet Vehicle

Source. The award is valid from 8/28/19 through 8/27/22 with the option to renew for two additional years. Trucks and vans are awarded items under contract.

The typical route of purchasing vehicles is to complete a formal Request for Quote (RFQ) and solicit bids from various vendors to ensure competitive pricing. However, due to a nationwide chip shortage and new vehicles not being built until FY2023 the only option may be to purchase vehicles that dealers have in inventory. The Purchasing Department will reach out to all vendors in southern CA for availability and may only find selected vendors that have in inventory of vehicles that meet department needs. Due to the supply chain issue and limited availability of vehicles this may result in a single source purchase. If a single source is the only option, the Department will return to the Board of Supervisors for approval of the single source purchase.
