

AN ORDINANCE OF THE COUNTY OF RIVERSIDE REGULATING THE CONSTRUCTION, RECONSTRUCTION, ABANDONMENT AND DESTRUCTION OF WELLS AND INCORPORATING BY REFERENCE ORDINANCE NO. 725

This summary is presented pursuant to California Government Code Sec-tion 25124(b); a certified copy of the full text of Ordinance No. 682.6 may be examined at the Office of the Clerk of the Board of Supervisors of the County of Riverside located at 4080 Lemon Street, 1st Floor, Riverside, California California.

Ordinance No. 682 allows the Department of Environmental Health to is-sue permits and oversee the construction, reconstruction, abandonment or destruction of wells throughout Riverside County. The ordinance ref-erences State statute and guidance to shape the standards for these ac-tions.

- Ordinance 682.6 makes three changes:
 Section 2. Added definition for "Driven Well"
 Section 3.A.2. Clarify that temporary holes/borings for environmental assessments do not require a permit
 Attachment A Incorporate a map showing a known perched aquifer for consideration of additional well requirements


