SUMMARY OF PROPOSED ORDINANCE NO. 682.6

**AN ORDINANCE OF THE COUNTY OF RIVERSIDE
REGULATING THE CONSTRUCTION, RECONSTRUCTION,
ABANDONMENT AND DESTRUCTION OF WELLS AND
INCORPORATING BY REFERENCE ORDINANCE NO. 725**

This summary is presented pursuant to California Government Code Section 25124(b); a certified copy of the full text of Ordinance No. 682.6 may be examined at the Office of the Clerk of the Board of Supervisors of the County of Riverside located at 4080 Lemon Street, 1st Floor, Riverside, California.

Ordinance No. 682 allows the Department of Environmental Health to issue permits and oversee the construction, reconstruction, abandonment or destruction of wells throughout Riverside County. The ordinance references State statute and guidance to shape the standards for these actions.

Ordinance 682.6 makes three changes:

- Section 2. - Added definition for "Driven Well"
- Section 3.A.2. - Clarify that temporary holes/borings for environmental assessments do not require a permit
- Attachment A - Incorporate a map showing a known perched aquifer for consideration of additional well requirements

The Riverside County Board of Supervisors approved a Form 11 initiating a public hearing and adoption of the ordinance on August 17, 2021.

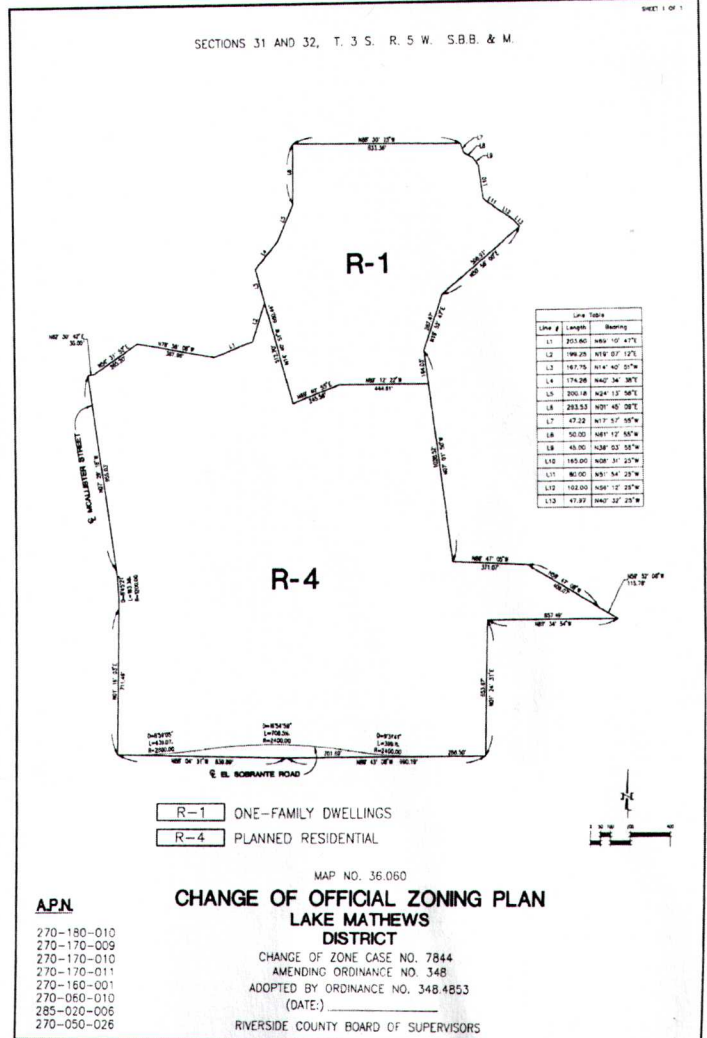

 AN ORDINANCE OF THE COUNTY OF RIVERSIDE
 AMENDING ORDINANCE NO. 348 RELATING TO ZONING

The Board of Supervisors of the County of Riverside ordains as follows:

- Section 1. Section 4.1 of Ordinance No. 348, and Lake Mathews District Zoning Plan Map No. 36 as amended, are further amended by placing in effect in the zone or zones as shown on the map entitled "Change of Official Zoning Plan, Lake Mathews District, No. 36.060, Change of Zone Case No. 7844," which map is made a part of this ordinance.
- Section 2. This ordinance shall take effect 30 days after its adoption.
