Authorize the Purchasing Agent, in accordance with Ordinance No. 459, based on the availability of funding and as approved as to form by County Counsel to: (a) sign amendments that exercise the options of the agreement including modifications of the statement of work that stay within the intent of the agreement; and (b) sign amendments to the compensation provisions that do not exceed the sum total of ten percent (10 %) of the total cost of the agreement.

### **BACKGROUND:**

### <u>Summary</u>

Juvenile Detention Policy Manual, Law Enforcement Policy Manual and Training Bulletin services provided by Lexipol, LLC are tools utilized by multiple law enforcement agencies, fire departments, and other public safety departments. These services assist with mitigating risk and reducing policy development cycle time, while allowing for customization specific to the County of Riverside Probation Department.

Lexipol, LLC provides the County with ability to update policy manuals; includes 24/7 access to a Knowledge Management System for updates, editing, and online annual subscription. The services provide the County with the tools to maintain current policy that reflects changes in legislative mandates and regulatory requirement changes and revisions such as those made by the California Corrections Standards Authority. Lexipol, LLC can now provide a Probation Policy Manual to meet Probation's specific policy requirements. The features of the web-based system for the Juvenile Detention and Probation Policy Manuals assist in reducing risk and staying ahead of litigation trends while communicating clear and concise policy guidance to the Probation Department staff.

### Impact on Residents and Businesses

The agreement with Lexipol, LLC will provide an effective tool for Probation operation in the county.

### **Contract History and Price Reasonableness**

In 2015 an Agreement with Lexipol, LLC was executed using Purchasing Agent authority, without seeking competitive bids (Purchasing approved SSJ# 15-326 and SSJ amendments).

On August 19, 2020, a new Agreement (PRARC-95658-002-06/25) with Lexipol, LLC was executed using Purchasing Agent authority without seeking competitive bids (Purchasing approved SSJ# REQ1349011121). This Agreement included implementation of the Juvenile Detention Policy Manual.

This Amendment No.1 before the Board seeks approval as it will terminate the Law Enforcement Policy Manual and add as it's replacement a specific department subscription for a Probation Policy Manual and Daily Training Bulletins with supplemental publication services. Additionally, it will extend the term out through June 30, 2025, without seeking competitive bids (Purchasing Approved SSJ# REQ154054821) for a total aggregate amount of \$285,971.

Lexipol, LLC has provided the County with a 50% discount for the purchase and implementation price of the Probation Policy Manual subscription for the first two years of service, FY21/22 and FY22/23 and a 25% discount for FY23/24 and FY24/25.

This Amendment No. 1 to the Service Agreement for Lexipol Law Enforcement and Juvenile Detention Annual Subscription Policy Manual is entered into by and between County of Riverside (COUNTY) and Lexipol, LLC., a Delaware limited liability company (CONTRACTOR).

WHEREAS, COUNTY and CONTRACTOR entered into that Service Agreement for Law Enforcement and Juvenile Detention Annual Subscription Policy Manual services, effective September 29, 2020 (the "Agreement");

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement to modify the Law Enforcement Annual Subscription to the Probation Annual Subscription, effective March 1, 2022.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

- 1. The above recitals are true and correct and are incorporated herein by reference.
- 2. The second sentence of Section 3.1 of the Agreement ("Compensation") is deleted in its entirety and replaced with the following: "The aggregate amount of this Agreement shall not exceed two hundred eighty-five thousand, nine hundred seventy dollars and six-four cents (\$285,970.64) for the remaining period of performance, consistent with Exhibit B-1."
- 3. Exhibit A (Scope of Service) is deleted from the Agreement in its entirety and replaced with the attached Exhibit A-1 (Scope of Service). All references in the Agreement to Exhibit A shall now mean and refer to Exhibit A-1.
- Exhibit B (Payment Compensation) is deleted from the Agreement in its entirety and replaced with the attached Exhibit B-1 (Payment Provisions). All references in the Agreement to Exhibit B shall now mean and refer to Exhibit B-1.
- All other terms and conditions of the Agreement not modified herein shall remain 5. unchanged.
- 6. This Amendment No. 1 shall be effective March 1, 2022.
- This Amendment No. 1 may be executed in any number of counterparts, each of which will be an original, but all of which together will constitute one instrument. Each party of this Amendment agrees to the use of electronic signatures, such as digital signatures

### **EXHIBIT A-1**

#### SCOPE OF SERVICE

 Lexipol, LLC (CONTRACTOR) shall provide the County of Riverside Probation Department (COUNTY) risk management services, a web-based policies and procedures manual that shall be customized for the COUNTY. This shall provide the tools to maintain current policy that reflects changes in legislative mandates and regulatory requirement changes/revisions, such as those made by the California Corrections Standards Authority.

### 2. CONTRACTOR shall provide:

- 2.1. Annual Probation Policy Manual and Juvenile Detention Policy Manual subscriptions which shall include 24/7 access, daily training bulletins with supplemental publication services for updates, editing, and online annual subscription to Probation/Juvenile Detention Procedure Manuals.
- 2.2. Implementation of Annual Probation Policy Manual and Daily Training Bulletins with Supplemental Publication Service.
- 2.3. Urgent updates to change policy as a result of precedent setting Court decisions, urgent legislation, or extraordinary incidents for County of Riverside Probation field offices and juvenile facilities.
- 2.4. Daily safety briefings with risk management to identify areas in need of concentration. Providing the ability to modify policy content by the COUNTY via proprietary on-line tools.
- 2.5. Customized updates to provide client alerts, assuring timely revisions are implemented.
