4. Direct the Clerk of the Board of Supervisors to file the Notice of Exemption with the

BACKGROUND:

Summary

The County of Riverside Transportation Department is proposing to construct a protective reinforced concrete slab over the Colorado River Aqueduct (CRA) located beneath Elm Street between approximately 1,500 feet north of Adele Avenue to 1,900 feet north of Adele Avenue in the community of Cabazon in Supervisorial District 5.

Elm Street is classified as a Collector in the County of Riverside's General Plan. Elm Street is a two-lane road and currently ranges from 24-25 feet wide. A protective concrete slab is needed due to the importance of the CRA bringing water to communities and the limited soil cover over the CRA. Mainly, the work will consist of constructing a two foot thick protective concrete slab supported by spread footings reinforced with steel bars.

Additional improvements include constructing a widened asphalt concrete approach section, construction of a concrete drainage swale, reconstructing the asphalt concrete pavement and driveway, relocation of fence, shoulder backing and grading, utility adjustments, placement of traffic striping, placement of signs, and other associated work.

The Transportation Department will select the contractor based upon the lowest responsive and responsible bid for the sum of all bid schedules.

Environmental Findings

The proposed project is exempt from CEQA under Section 15301 (c) – Existing Facilities exemption because the Elm Street protective concrete slab does not create additional traffic lanes and involves negligible or no expansion of existing or former use of the existing roadways and associated facilities.

Impact on Citizens and Businesses

The purpose of this project is to provide a protective cover over the CRA which provides water services to numerous communities. The protective slab is needed due to the existing limited soil cover and lack of protection over the CRA.

The work is scheduled to begin in summer 2022. The work will include a fourteen-calendar day full-closure on Elm Street with 24 hour shifts to excavate, grade, form, place rebar, pour concrete, cure concrete, and any other associated work to construct the protective concrete slab. Traffic will be detoured through Broadway Street and Esperanza Avenue for commuters traveling to and from the community of homes to the south of Elm Street. The remaining work will be phased to keep the road open, although reduced to a single lane at times, during construction and will take approximately five weeks to complete.

SUPPLEMENTAL:

Additional Fiscal Information

The construction contract is estimated to cost approximately \$476,700. The County improvements will be funded with Gas Tax/HUTA.

There are no General Funds used in this project.

PROJECT DESCRIPTION: The County of Riverside Transportation Department is proposing to construct a protective reinforced concrete slab over the Colorado River Adequate (CRA) located beneath Elm Street between approximately 1,500 feet north of Adele Avenue to approximately 1,900 feet north of Adele Avenue. Elm Street is classified as a collector in the County of Riverside's General Plan. Elm Street is a two lane road and currently ranges from 24-25 feet wide. The proposed project will consist of constructing a reinforced concrete slab over the CRA owned and operated by the Metropolitan Water District (MWD). The slab will be 2 feet thick supported by spread footings and will provide protection for the CRA below.

The proposed project will also include:

- Construction of widened asphalt concrete approach sections
- Construction of concrete drainage swale
- Reconstruction of asphalt concrete pavement and driveway
- Relocation of fence
- Shoulder backing and grading
- Utility adjustments
- Striping of roadway, including pavement markers and reflectors
- Salvage/removal and installation of new signs

ENVIRONMENTAL ANALYSIS:

Temporary construction easements may be required for the proposed improvements.

A drainage easement over the CRA is needed for this project. The project improvements will not be within the existing footprint of the roadway and will modify the existing roadway profile.

This project is subject to compliance with the County WRMSHCP. In accordance with Section 7 of the Western Riverside County MSHCP, necessary operation and maintenance along existing roadways are considered a covered activity outside of cell criteria areas. This project is considered

to be an operation and maintenance activity; therefore, it is a covered activity under the Western Riverside County MSHCP.

If tree and/or vegetation removal takes place during the migratory bird breeding season (February 15th – August 31st), a preconstruction nesting survey will be conducted pursuant to the Migratory Bird Treaty Act (MBTA).

The County of Riverside Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA), based on the following:

Section 15301 (c) – Existing Facilities – The project proposes to construct a protective reinforced concrete slab over the Colorado River Adequate (CRA) located beneath Elm Street. The project in its entirety is consistent with Section 15301(c) because it does not create additional traffic lanes and involves no expansion of use of the existing roadway and associated facilities.




