#### BACKGROUND:

#### Summary

California Revenue and Taxation Code (2700-2708) authorizes counties to collect real property taxes in two installments per year. Many real property owners pay their property taxes in monthly installments through escrow accounts with the banks that own their mortgages. Real property owners who own their property outright, or do not have escrow accounts, do not have the option to pay their property taxes to the county in monthly installments. For some, paying the biannual property tax bill creates a financial hardship or considerable inconvenience.

Easy Smart Pay is a product and service of Smart Easy Pay, a privately held corporation founded in partnership with the California State Association of Counties (CSAC) Financing Corporation with the aim of filing service gaps between government agencies and the public regarding taxes. Easy Smart Pay allows individual property owners to voluntarily assign (and unassign) their property tax bills to Easy Smart Pay, which will in turn bill them for that amount over monthly installments for a fee. The fees are currently 2.25% for Credit/Debit and electronic checks. However, with Riverside County joining in with the other counties that currently utilize Easy Smart Pay, there is a possibility of reducing their fee to 2%. By comparison, the County's processing fee for Credit payments is 2.28%, \$3.95 for Debit payments and 0% for electronic checks. Any fees collected because of using Easy Smart Pay, in excess of the property taxes due, are retained by Easy Smart Pay, not the County. Easy Smart Pay will remit the total taxes due for the enrolled property owners to the County in the same manner used by banks and financial institutions that interact with the County's property tax system. Paying property taxes in monthly installments is sometimes more convenient for property owners and has been a regular request the Treasurer-Tax Collector has received from residents.

The program has been reviewed by the Treasurer-Tax Collector and County Counsel. Because the service fulfills an expressed constituent need, the Treasurer-Tax Collector seeks approval to promote the service within the County where appropriate.

### Impact on Residents and Businesses

Promoting the "EasySmartPay" Program comes at no cost or financial benefit to the county but would fulfill constituents need that have expressed a desire for a monthly installment option for

## RESOLUTION OF THE BOARD OF SUPERVISORS OF

THE COUNTY OF RIVERSIDE AUTHORIZING THE ACCEPTANCE AND PROMOTION OF THE EASYSMARTPAY PROGRAM AS AN OPTION FOR TAXPAYERS TO PAY SECURED PROPERTY TAXES IN MONTHLY INSTALLMENTS

WHEREAS, the Revenue and Taxation Code allows the County of Riverside to collect real property taxes in two installments per year; and

WHEREAS, many real property owners pay their property taxes in monthly installments through escrow accounts with the banks that own their mortgages; and

WHEREAS, real property owners who own their property outright do not have the option to pay their real property taxes to the county in monthly installments; and

WHEREAS, for some, paying the biannual property tax bill creates a financial hardship or considerable inconvenience; and

WHEREAS, under current law, the Treasurer-Tax Collector lacks the authority to bill real property tax payments in monthly installments; and

WHEREAS, Smart Easy Pay, Inc., a partner company of the California State Association of Counties Financing Corporation, offers the "EasySmartPay" program to taxpayers on a voluntary basis for a fee comparable to the processing fee that the Tax Collector currently charges for credit card or debit card payments; and

WHEREAS, the county's property tax payers have expressed a desire for a monthly installment option for the payment of property taxes to the Treasurer-Tax Collector; and

WHEREAS, the acceptance and promotion of the EasySmartPay service would not result in any financial benefit to the county; and

WHEREAS, promoting EasySmartPay at no cost to the county would benefit the county's property tax payers by informing them of a desired option;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of Riverside, in regular session assembled on March 29, 2022, that the Treasurer-Tax Collector is authorized to allow, accept and promote the use of EasySmartPay as an option for property owners to pay property taxes in monthly installments for a fee commensurate with the county's processing fees for credit card and debit card payments of property taxes.
