3. Direct the Clerk of the Board to record the attached Notice of Completion.



BACKGROUND:

Summary

On December 15, 2020 (Item 3.26), the Board of Supervisors approved the recommendation of the Public Safety Enterprise Communications (PSEC) Steering Committee to increase public safety communications by the addition of a remote simulcast site to the Northwest Cell of the PSEC communication system. The additional site expanded the coverage performance of that cell and resulted in greater PSEC system function in that area. The project included design, staging, shipment, and installation of the site equipment including backup generators, fuel tanks and radio towers and specialized equipment housing from Pepro. The equipment from Pepro was purchased by the Sheriff using a purchase order for goods. The total cost of the project was estimated at \$946,767, including \$68,322 in contingency. This project was funded by two funding sources: 30% from PSEC Funds and 70% from City of Corona Funds.

The project was completed in December 2021 and Sheriff's PSEC is requesting the Notice of Completion (NOC) be completed and recorded by the Clerk of the Board.

Impact on Residents and Businesses

The PSEC system provides critical countywide communication for first responders and emergency management teams who serve and protect the community. Enhancing coverage in this area further improved communication for these agencies across Riverside County.

Additional Fiscal Information

All costs associated with this Board action were previously approved on December 15, 2020 (Item 3.26) in the amount of \$946,767, and the approved budget and funding breakdown is reflected below.
