On motion of Supervisor Spiegel, seconded by Supervisor Perez, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, March 25, 2022, be adjourned in memory of Dr. Armando Navarro, retired UC Riverside professor and forceful advocate for Latino and immigrant rights, who passed away on April 10, 2022.

Navarro taught and inspired numerous students, many of them young Latinos who were looking for a role model. Many of his students went on to become judges, journalists, lawyers, professors and holders of public office.

Navarro organized the regional conferences and meetings to bring the Chicano community together to address issues. He directed marches protests and rallies across the Inland Empire, Los Angeles, at the international border and in other countries. In early 2006, as coordinator of the National Alliance for Human Rights, Navarro organized and directed a national summit at the Riverside Convention Center. In May 2006, Navarro led more than 3,000 people on a march through downtown Riverside. Over the summer he fought a San Bernardino city initiative that would have made it illegal to hire or rent homes to undocumented immigrants.

Navarro was a fiery, inspiring speaker. He was also someone who stepped in and took action, when others were too scared to do so, and he encouraged his students to take action, "to take their knowledge out for a spin."

Navarro's memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.
