Re: Notice to Preserve Paper and Electronic Evidence

New California State Movement

I represent the New California State Movement in the statistical anomalies we have found in ballot tabulations in the November, 2020 General Election and the recent 2021 Recall Election in which your office is the repository of all ballots and electronic records of vote tabulations. This letter requests your immediate action to preserve all paper ballots without respect to how those ballots were generated, and all electronically stored information that may contain evidence important to the full forensic audit and verification of the accuracy of all vote tallies in the above-mentioned elections.

Briefly, the New California State Movement intends to conduct a full forensic audit of the votes in both elections.

This notice applies to your County's on- and off-site paper ballot storage and all on-and-off-site computer systems and removable electronic media and storage and retrieval systems plus all computer systems, services, and devices (including all remote access and wireless devices) used for your office's overall operation. The records and electronic media and storage and retrieval systems include but are not limited to, all e-mail and other electronic communications; electronically stored documents, records, images, graphics, recordings, spreadsheets, databases; calendars, system usage logs, contact manager information, telephone logs, internet usage files, deleted files, cache files, user information, and other data. Further, this notice applies to archives, backup and disaster recovery tapes, discs, drives, cartridges, voicemail and other data. All operating systems, software, applications, hardware, operating manuals, codes, keys, and other support information needed to fully search, use, and access the electronically stored information must also be preserved.

The importance of immediate action cannot be overstated. The electronically stored information is easily corrupted, altered, and deleted in normal daily operations. Even booting a drive, running an application, or reviewing a document can permanently alter evidence. An important method for reserving data in its original state is to have a forensic image (mirror image

or clone image) made of pertinent hard drives of both office and home computers used for business and of network servers. This image captures all current data, including the background or metadata about each document.

Simply copying data to a CD-ROM or other common backup medium is not adequate.

For each captured image file, record and identify the person creating the image and the date of creation. Secure the file to prevent subsequent alteration or corruption and create a chain of custody log. Once the forensic data image file is created, the pertinent computer or other device can be placed back into operation.

Please identify any key persons', officers', supervisors', and employees' computers to which special attention for forensic imaging must be directed.

This preservation notice covers the above items and information between the following dates: October 1, 2020, through June 30, 2022.

Follow the above procedures to preserve electronic information created after this notice.

Current law and rules of civil procedure clearly apply to the discovery of paper and electronically stored information just as they apply to other evidence, and confirm the duty to preserve such information for discovery. Your county and your officers, employees, agents, and affiliated organizations must take all reasonable steps to preserve this information until this legal matter is finally resolved. Failure to take the necessary steps to preserve the information addressed in this letter or other pertinent information in your possession or control may result in serious sanctions or penalties and any failure to preserve as requested may cause a future judge to instruct a future jury that a failure to preserve evidence may be construed as an admission that the record is not reliable and should, therefore, lose its certification for that election.

Further, to properly fulfill your preservation obligation, stop all scheduled data destruction, electronic shredding, rotation of backup tapes, and the sale, gift or destruction of hardware. Notify all individuals and affiliated organizations of the need and duty to take the necessary affirmative steps to comply with the duty to preserve evidence.

Your acknowledgment of the receipt of this letter and your concurrent duty to keep, preserve, safeguard, and disclose the requested information is appreciated.

Good morning board members

Since I won't be able to join you in person tomorrow I thought I would share a couple of thoughts. It's good that there is a renewed focus on voting and elections but unfortunately the horse escaped the barn and is running into oncoming traffic.

For a number of sessions I discussed the 2020 election, the Carter/Baker recommendations and implementing the VCA. Since the Governor approved mail-in balloting for the state and the implementation of the VCA at the county level I'm not sure the systemic deficiencies can be overcome.

As you know the recommendations of the C/B commission were to require voter id, limit mail in ballots, clean up the voter rolls, increase election observers and eliminate or secure machines. On top of all that, a day before Lin Wood's tweet, 12 out of 15 UBS board members quit their positions. Among them was Ye Xiang. Another most recent individual to walk away was Cheng Yixun, a financial expert

Dominion's Core Infrastructure Manager of Information Technology, Andy Huang, previously worked for China Telecom, a Chinese Communist affiliated company.

The investigation, conducted by Austin Security and Investigation Solutions, centers on Staple Street Capital, which acquired Dominion Voting Systems in 2018.

Dominion Voting Systems operates voting machines in at least 28 states, including the swing states involved in deleting millions of votes for Trump in addition to switching votes to Biden on election night.

“On Oct 8, 2020, Staple Street Capital filed SEC Form D offerings and sales amount of \$400,000,000 with the Sales Compensation Recipient identified as UBS Securities,” the investigation release stated.

They also noted a previous payment of \$200,000,000 was received in December 2014, leading up to the eventual Hillary Clinton vs. Donald J. Trump presidential election campaigns.

“UBS Securities is a swiss investment bank which owns 24.99% of UBS Securities Co LTD, a Chinese Investment Bank. The remaining 75% of UBS Securities CO LTD is owned by the Chinese government,” states the report.

After the Hunter Biden deal with the Chinese operatives was finalized, they christened the new firm Bohai Harvest RST (BHR). The partners set out to raise \$1 billion for the new fund.

Hunter then introduced his father to Chinese private equity executive Jonathan Li, who became CEO of BHR after the deal’s conclusion. Soon they became a \$2.1 billion company with Hunter’s firm holding an equity stake. Other investors include China Development Bank and China’s social security fund.

Under the terms of the original deal, Rosemont Seneca, Hunter’s firm, shared a 30% stake in BHR with the Thornton Group, which was run by James Bulger, the son of longtime Massachusetts state Senate President Billy Bulger.

Hunter and Bulger joined the board, along with Devon Archer, Hunter’s longtime business partner. Archer would also serve as vice chairman of the fund’s investment committee.

Stealing U.S. Technology

In 2015, BHR acquired Henniges Automotive, a Michigan-based producer of vibration-dampening equipment, alongside Chinese military contractor Aviation Industry Corp. of China (AVIC).

Given the military applications of Henniges’ technology, the deal required federal approval. Like CGN, AVIC **was suspected of stealing US technology for its purposes.**

Not long after the Henniges deal closed, AVIC debuted its new J-20 fighter — incorporating designs **allegedly stolen from the US F-35 program.**

By May 2017, Hunter met with Ye Jianming, chairman of Chinese energy company CEFC, to discuss more investment opportunities in the US. After the meeting, Ye sent a 2.8-carat diamond to Hunter along with a “thank you” card.

When, six months later, a CEFC executive was arrested in New York on unrelated bribery charges, his first phone call was to Hunter's uncle, James Biden.

On December 1, Trump-hired attorney Lin Wood first revealed that China bought Dominion for \$400 million. Despite providing the [SEC form D](#) for this claim, it was not quite correct. Namely, the link between Dominion and China was not as straightforward as Wood first claimed. However, the convoluted chain of links does connect Dominion to China in some way:

- The payer of the \$400 million was UBS Securities LLC, which is a subsidiary of Swiss investment bank UBS.
- The receiver of the payment was Staple Street Capital, which previously bought Dominion Voting Systems in 2018.
- The payment occurred on October 8, 2020.
- Although there is a Chinese bank and investment firm named 'UBS Securities', it is UBS Securities Co. Ltd (based in Beijing), not UBS Securities LLC (based in New York).
- However, with regard to UBS Securities LLC (based in New York), three out of four board directors were Chinese nationals. One of them, Ye Xiang, also served on board of the other subsidiary, UBS Securities Co. Ltd (based in Beijing). He also worked for China's central bank.
- **UBS received a special, fully-licensed status in China, which is rarely given to foreign banks.**
- The deal broker was none other than Chinese vice premier Wang Qishan, who has a reputation as a finance specialist in the Chinese government.

On top of all that, a day before Lin Wood's tweet, 12 out of 15 UBS board members quit their positions.

Among them was Ye Xiang. Another most recent individual to walk away was Cheng Yixun, a financial

expert from **Chinese's Thousand Talents**

Program and the ex-CEO of Beijing-based UBS Securities Co. Ltd. Interestingly, the

Thousand Talents Program has been widely [covered by the US media](#) as a security threat to America's national interests.

~~BEIJING NEWS WEEK & DOCS~~ Dominion itself had Chinese insiders. Among them is Andy Huang, the Dominion's Core Infrastructure Manager of Information Technology. Andy previously worked for China Telecom, from 1998 to 2002. Needless to say, such vital companies are tightly controlled by the Chinese government.

The investigation, conducted by Austin Security and Investigation Solutions, centers on Staple Street Capital, which acquired Dominion Voting Systems in 2018.



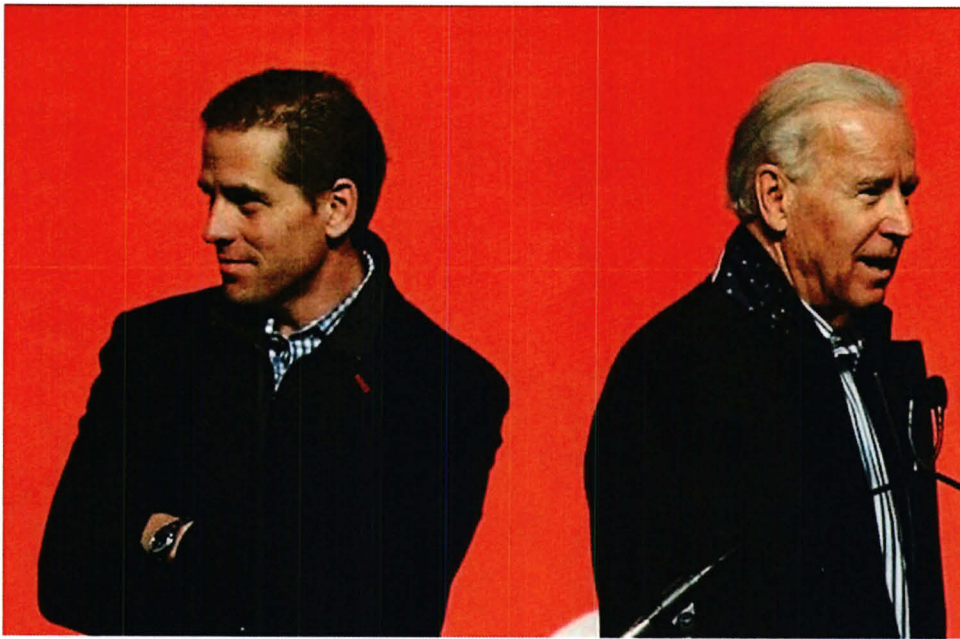
Dominion Voting Systems operates voting machines in at least 28 states, including the swing states involved in deleting millions of votes for Trump in addition to switching votes to Biden on election night.

“On Oct 8, 2020, Staple Street Capital filed SEC Form D offerings and sales amount of \$400,000,000 with the Sales Compensation Recipient identified as UBS Securities,” the investigation release stated.

They also noted a previous payment of \$200,000,000 was received in December 2014, leading up to the eventual Hillary Clinton vs. Donald J. Trump presidential election campaigns.

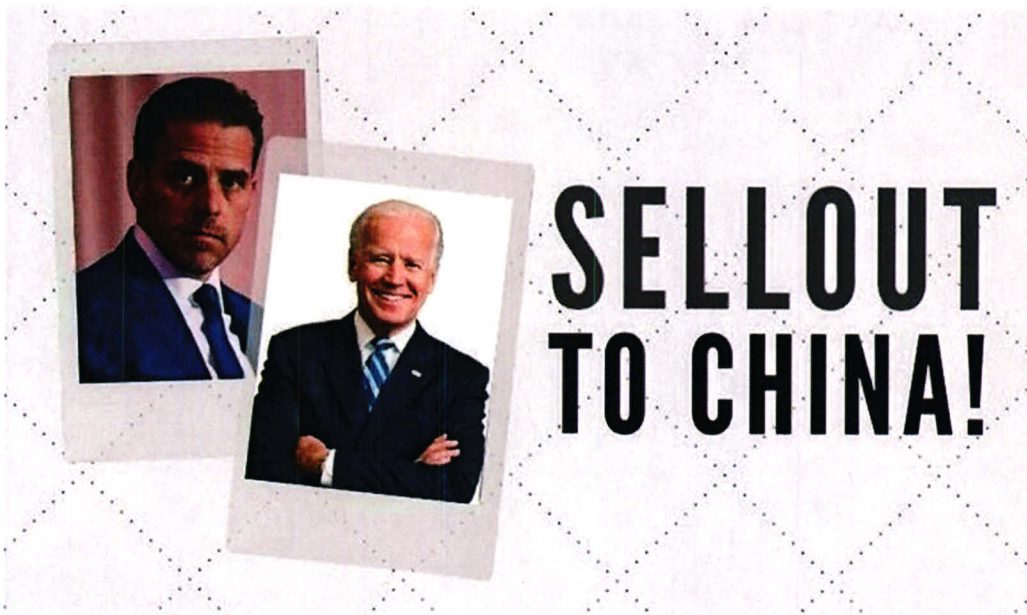

“UBS Securities is a swiss investment bank which owns 24.99% of UBS Securities Co LTD, a Chinese Investment Bank. The remaining 75% of UBS Securities CO LTD is owned by the Chinese government,” states the report.



After the Hunter Biden deal with the Chinese operatives was finalized, they christened the new firm Bohai Harvest RST (BHR). The partners set out to raise \$1 billion for the new fund.

Hunter then introduced his father to Chinese private equity executive Jonathan Li, who became CEO of BHR after the deal's conclusion. Soon they became a \$2.1 billion company with Hunter's firm holding an equity stake. Other investors include China Development Bank and China's social security fund.



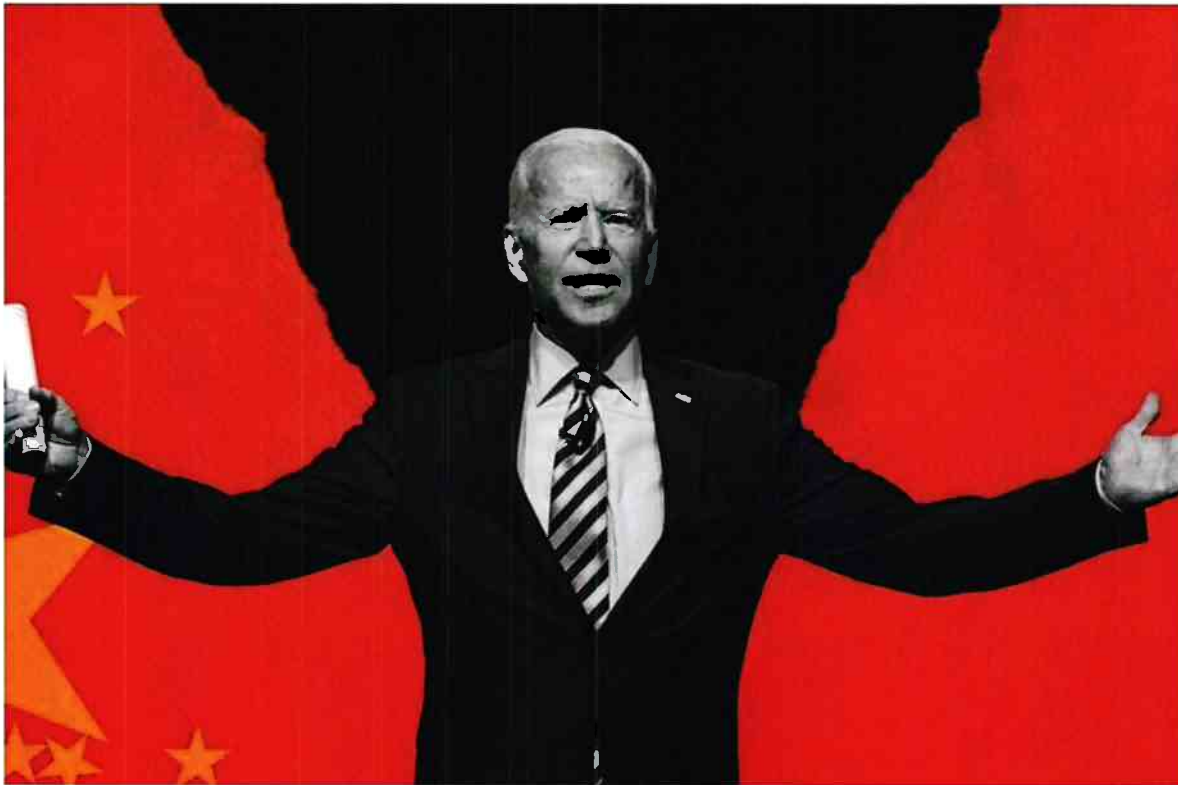
Under the terms of the original deal, Rosemont Seneca, Hunter's firm, shared a 30% stake in BHR with the Thornton Group, which was run by James Bulger, the son of longtime Massachusetts state Senate President Billy Bulger.

Hunter and Bulger joined the board, along with Devon Archer, Hunter's longtime business partner. Archer would also serve as vice chairman of the fund's investment committee.

Stealing U.S. Technology

In 2015, BHR acquired Henniges Automotive, a Michigan-based producer of vibration-dampening equipment, alongside Chinese military contractor Aviation Industry Corp. of China (AVIC).

Given the military applications of Henniges' technology, the deal required federal approval. Like CGN, AVIC was **suspected of stealing US technology for its purposes.**



Not long after the Henniges deal closed, AVIC debuted its new J-20 fighter — incorporating designs **allegedly stolen from the US F-35 program.**

◆ By May 2017, Hunter met with Ye Jianming, chairman of Chinese energy company CEFC, to discuss more investment opportunities in the US. After the meeting, Ye sent a 2.8-carat diamond to Hunter along with a “thank you” card.

When, six months later, a CEFC executive was arrested in New York on unrelated bribery charges, his first phone call was to Hunter's uncle, James Biden.



“Ye, now accused of bribing a Communist Party official, has since been detained in his native China,” reported the New York Post on October 10, 2020.
