ORDINANCE NO. 767.25
AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 767 DELEGATING AUTHORITY TO THE COUNTY TREASURER TO INVEST AND REINVEST FUNDS OF THE COUNTY AND OTHER DEPOSITORS AND TO DEPOSIT FOR SAFEKEEPING CERTAIN INSTRUMENTS IN IDENTIFIED FINANCIAL INSTITUTIONS
The Board of Supervisors of the County of Riverside ordains as follows:
Section 1. Subsection a of Section 3 of Ordinance No. 767 is amended to read as follows:
"a. The authority to invest or to reinvest funds of a local agency, or to sell or exchange securities so purchased, for a period of one year from the effective date of this ordinance, with such delegation expiring on November 19, 2022. The County Treasurer shall assume full responsibility for these transactions either until the Board of Supervisors revokes this delegation of authority by ordinance or until the delegation expires. The Board of Supervisors may renew this delegation of authority for subsequent one-year periods by adopting an amendment to this ordinance."
Section 2. EFFECTIVE DATE. This ordinance shall take effect thirty (30) days after its adoption.

SUMMARY OF ORDINANCE NO. 348.4966

AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 348 RELATING TO ZONING

This summary is presented pursuant to California Government Code Section 25124(b): a certified copy of the full text of Ordinance No. 348.4966 may be examined at the Office of the Clerk of the Board of Supervisors of the County of Riverside, located at 4080 Lemon Street, 1st Floor, Riverside, California.

Ordinance No. 348.4966 is a countywide ordinance amending Article XIXa related to temporary events held in the unincorporated area of Riverside County. Ordinance No. 348.4966 establishes permitting requirements, bond and insurance requirements and approval requirements for temporary events. Approval requirements include, among others, no pending code enforcement actions on the lot, approved parking plan, approved fire protection plan, approved security plan, approved sewage disposal plan, and noise, dust and lighting mitigation plans. Ordinance No. 348.4966 also specifies the type of temporary events prohibited in the County of Riverside. Additionally, Ordinance No. 348.4966 establishes new definitions and classes for temporary events depending on size and location, hours of operation, and allows overnight stays when specific requirements are met by the permittee. Ordinance No. 348.4966 will take effect 30 days after the ordinance is adopted by the Riverside County Board of Supervisors.
