

BACKGROUND:

Summary

The Coachella Valley Association of Governments (CVAG) has a 15-year partnership with the County of Riverside and all 4th District cities in addressing homelessness in the Coachella and Palo Verde Valleys through the CVAG Homeless Committee. CVAG has been operating their CV Housing First program for five years. Originally CVAG contracted services for this program through Path of Life Ministries. In January 2021, CVAG brought the CV Housing First program in house. This program provides outreach, placement in crisis stabilization units, and intense case management with a high success rate of placement into permanent housing.

Due to the intense outreach, case management, and scattered crisis stabilization units throughout the Valley, staff is required to utilize vehicle transportation for most of their duties. This has led to high reimbursement rates for CVAG. By allocating two vehicles to CVAG, they will be able to utilize these for the services provided in the CV Housing program and minimize the wear and tear on the employee's vehicles.

This item authorizes the director of Purchasing and Fleet to work with other county departments to locate two (2) suitable vehicles. The vehicles may come from Purchasing and Fleet's inventory, or the inventory of another department with suitable vehicles. The residual cost of surplus vehicles averages \$8,000 and is a cost to the department facilitating the donation.
