Ron was the owner-operator of Bayhurst Pool and Spa, bringing happiness and fun to families throughout Riverside County for nearly 40 years.

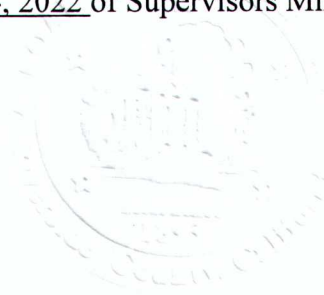
Ron was preceded in death by his wife, Sharon, and survived by his loving daughters, twelve grandchildren, and two great-grandchildren.
