

BACKGROUND:

Summary

On May 21, 2019, Item 3.16, the Board of Supervisors (Board) approved the Maintenance Service Contract No. 4, between the County of Riverside (County) and ACCO through the Easy Indefinite Quantity Construction (EZIQC) contract for the RCIT Data Center AC Maintenance Project in the amount of \$257,000. A deductive change order in the amount of \$28,279 was approved reducing the contract value to \$228,721.

Air Conditioning (AC) Maintenance Service agreements are needed for the annual service and repair of the AC equipment at three RCIT data centers located in the City of Riverside: RC3 Data Centers located at (No.1) 1960 Chicago Avenue, Riverside; (No.2) the Riverside County Innovation Center (RCIC) located at 3450 14th Street, Riverside; and (No.3) the Riverside County Administrative Center (CAC) is located at 4080 Lemon Street, Riverside. The contract consists of providing ongoing repairs, service and preventative maintenance, including but not limited to: response for emergency mechanical repairs, monthly maintenance and quarterly filter changes; and annual belt replacement to critical county AC equipment.

ACCO has completed the work and the Project has been inspected and found to comply with the contract and safety requirements. This Board action will release the undisputed contract retention funds in the amount of \$11,436 to ACCO after the Notice of Completion has been recorded and the 35-day lien period has expired from the start of the recorded date, per contract terms and applicable law.

Impact on Residents and Businesses

Managing one maintenance agreement that includes the three facilities has prolonged the life of the units, ensuring more consistent functionality and providing proper temperature control for the critical AC equipment to improve reliability of electronic equipment associated with the data centers providing public services.
