BACKGROUND:

Summary (continued)

Annually, the Riverside County Sheriff's Department (Sheriff) budgets for the purchase of vehicles as needed based on their operational needs and replacement schedule. For fiscal year 2021-22, the Sheriff requested to finance the purchase of one hundred eighty-three (183) vehicles of which twenty-two (22) are new vehicles, and one hundred sixty-one (161) are replacements since those vehicles have exceeded their useful life or have high mileages.

On June 15, 2021 as part of Board agenda item #3.31, the Sheriff was given approval to manage their fleet operation. This responsibility includes vehicle acquisition, maintenance, mechanical/accident repair, and vehicle disposal starting fiscal year 2021-22.

During the transition process from County Fleet to the Sheriff, the fiscal year 2021-22 new vehicle request (Schedule 23) outlining the one hundred eighty-three (183) vehicles was inadvertently not submitted through the standard budget process. This request of one hundred eighty-three (183) vehicles will not impact the Sheriff's budget because the vehicle cost was part of the department's initial budget request.

In addition, the Sheriff's Patrol Division is requesting an additional forty-five (45) Patrol Interceptor Utility (PIU) vehicles to be added to their fleet to support and meet the service levels requested by contract cities. This quantity also covers total loss vehicles resulting from accidents and unforeseen mechanical failures

In total, the Sheriff is requesting to purchase and finance a total of two hundred twenty-eight (228) vehicles in the estimated amount of \$9,126,460 through Banc of America Public Capital Corp (Banc of America).

Contract History and Price Reasonableness

The purchase of all the vehicles will be through the awarded vendors. These vendors were vetted and have gone through the bidding process in which their responses to the bid and

product requirements have been reviewed by a committee. As a result of the bids and based on cost, the lowest bidders were awarded the contracts. The bid number associated with the vehicle type and awarded vendors are listed below:

Impact on Residents and Businesses

The vehicles will be used to conduct Department business and provide frontline deputies the ability to patrol assigned areas to enforce laws and ordinance, regulate traffic, prevent crimes, and respond to critical incidents.

Additional Fiscal Information

The two hundred twenty-eight (228) vehicles listed below totaling an estimated \$9,126,460 will be financed through Banc of America, with the interest to be paid based on the terms of the line of credit agreement at the time of purchase.

All of the vehicles will be financed over 5 years (60 months), with the exception of one (1) bomb truck to be financed over 10 years (120 months). Of the quantity requested for FY 2021-2022, the department has received twenty-six (26) vehicles. Due to the current on-going market conditions related to microchip shortages and supply chain issues, the lead time of receiving vehicles is approximately eight (8) to twelve (12) months long.
