North High School where he enjoyed raising animals in the FFA, ditching class, and trips to the river. Friends remember Lloyd's sunny disposition and ability to make people laugh.

Lloyd had an adventurous spirit that led to a collection of irreplaceable experiences. He traveled to Korea after enlisting in the U.S. Army at age 17. He also competed as a rodeo bareback bronc rider. This spirit led him to take the chance and approach the love of his life, while cruising Magnolia Avenue one late summer night. They married in 1978.

Lloyd's adventure seeking spirit caught up with him in 1979. Shortly after learning they were expecting a child, Lloyd experienced an off-road motorcycle accident, that left him paralyzed and bound to a wheelchair for the remaining 43 years of his life. In the years that followed, he displayed tremendous resiliency and dedication. His spirit led him to seek new adventures.

Lloyd found and coached a wheelchair basketball team. In 1996 he traveled with his team to Japan to compete in a wheelchair sports exchange. Lloyd also spent time assisting individuals with spinal cord injuries at Loma Linda Medical Center. He retired from Riverside Community College where he worked as a Disabled Student Specialist.

Lloyd's memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.
