## SUBMITTAL TO THE BOARD OF SUPERVISORS COUNTY OF RIVERSIDE, STATE OF CALIFORNIA

## **JUSTIFICATION:**

The item came to the attention of the County subsequent to the agenda being posted and requires Board action by August 12, 2022, and the Board does not reconvene until August 29, 2022. The item is adoption of a Resolution changing the West Valley Water District's election date from June 2022 to the statewide general election in November 2022 to comply with Senate Bill 415. A majority of the West Valley Water District is located within San Bernardino County and a small portion is located in Riverside County. As such, the Resolution would need to be adopted by both counties.

On Friday, July 29, 2022, the San Bernardino County Counsel's office contacted Riverside County Counsel's office to explain the urgent need to adopt a resolution. San Bernardino County adopted its Resolution on July 26, 2022 and explained that Riverside County would need to adopt its Resolution by August 12, 2022.

Since this item requires action by August 12, 2022, and there is no meeting of the Riverside County Board of Supervisors until August 29, 2022, immediate action on this item is required to ensure that the West Valley Water District's election can proceed in November 2022.
