

BACKGROUND:

Summary

Sections 29100, 29101 and 29102 of the Government Code require the Board of Supervisors to adopt the tax rates and the levy of taxes for the County, School Districts, Cities and Special Districts on the Secured Tax Roll for each year.

In accordance with Section 29103 of the Government Code, the Office of the Auditor-Controller completed calculation and review of the required tax rates to be applied on the 2022/2023 County Secured Assessment Roll based on current law.

In accordance with Section 29106 of the Government Code, the Office of the Auditor-Controller now submits the attached listing of the 2022/2023 tax rates for adoption by the Board and for the levy of tax by the Board.

Impact on Residents and Businesses

Pursuant to Government Code §29100, the Board of Supervisors is required to adopt the current year's tax rates on or before October 3rd. Residents and businesses with a taxable interest in property would be subject to tax bill amount based on the Board's adoption of the tax rates and levying for the Secured Tax Roll for this Tax year. Residents and business will likewise benefit from the government services funded by the tax revenues generated by this process.

Contract History and Price Reasonableness

The tax rates calculated are based on state law. Debt service tax rates (debt rates) are the vehicle for raising the amount of taxes needed to pay an annual principal and interest payment on voter-approved indebtedness.

5 A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE
6 FIXING AND ADOPTING TAX RATES FOR AND LEVYING TAXES ON PROPERTY ON THE
7 SECURED TAX ROLL FOR FISCAL YEAR 2022-2023

9 WHEREAS, pursuant to Section 29100 of the County Budget Act (Title 3, Division 3,
10 Chapter 1 of the Government Code) (the "Act"), on or before October 3 of each year, the board of
11 supervisors of a county shall adopt by resolution the rates of taxes on the secured roll, not to exceed the 1-
12 percent limitation specified in Article XIII A of the Constitution and Sections 93 and 100 of the Revenue
13 and Taxation Code; and,

14 WHEREAS, pursuant to Section 29100 of the Act, for voter-approved indebtedness, the
15 board shall adopt the rates on the secured roll by determining the percentage of full value of property on
16 the secured roll legally subject to support the annual debt requirement; and,

17 WHEREAS, pursuant to Section 29101 of the Act, after adopting the rates of taxes, the board
18 of supervisors of a county shall levy the taxes upon the taxable property of the county in specific sums in
19 terms of the rates so adopted; and,

20 WHEREAS, pursuant to Section 29102 of the Act and unless otherwise provided by law, the
21 authority and duties of the county board of supervisors with respect to adopting tax rates and levying of
22 taxes prescribed in Article 5 of the Act shall have application to school districts and to special districts, or
23 zones or improvement districts thereof, whose affairs and finances are not under the supervision and control
24 of the county board of supervisors but for which a tax levy is carried on the regular county assessment roll;
25 and,

26 WHEREAS, pursuant to Section 29103 of the Act, it shall be the responsibility of the county
27 auditor to calculate the several tax rates for the board's action thereon; and,

1 WHEREAS, the Office of the Auditor-Controller of the County of Riverside has now
2 calculated the tax rates as shown on the schedule attached to this resolution (the "Schedule"); and,

3 WHEREAS, pursuant to Sections 2151 and 2152 of the Revenue and Taxation Code, the
4 board of supervisors of a county must fix the rates of county and district taxes and levy the state, county
5 and district taxes prior to the county auditor using those rates to compute the dollar amount of property
6 taxes and entering the computed amounts of property tax on the secured tax roll;

7 NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the Board
8 of Supervisors of the County of Riverside, in regular session assembled on August 30, 2022 at 9:30 am or
9 soon thereafter in the meeting room of the Board of Supervisors located on the 1st floor of the County
10 Administrative Center, 4080 Lemon Street, Riverside, California, that the rates of taxes for property on the
11 2022-2023 secured tax roll for the County of Riverside, county school districts, cities and special districts
12 for the fiscal year 2022-2023 as set forth in the Schedule are hereby fixed and adopted; and

13 BE IT FURTHER RESOLVED, DETERMINED AND ORDERED that, after fixing and
14 adopting the rates, the Board of Supervisors of the County of Riverside hereby levies the taxes on the
15 property on the secured tax roll for the County of Riverside, county school districts, cities and special
16 districts for the fiscal year 2022-2023.
