BACKGROUND:

Summary

The County of Riverside provides its employees and their dependents, and eligible retirees and dependents, with medical benefits including benefits for prescription drugs, including certain devices and supplies dispensed by pharmacists through the County's Exclusive Care Health Plan. The County released a Request for Proposal to establish an agreement with a Pharmacy Benefit Manager (PBM) for the benefits sponsored by the County.

The current PBM is Navitus Health Solutions, LLC. They have been providing benefits to Exclusive Care membership since 2009. Within the Inland Empire, Navitus contracts with over 350 pharmacies in Riverside County and nearly 300 in neighboring San Bernardino County. The current contract with Navitus expires September 30, 2023.

The Navitus Group Purchasing Organization (GPO) was created by Navitus to both decrease medication costs and optimize rebates through contracts with pharmaceutical manufacturers. This Amendment is required to opt-in to the Navitus GPO and allow the County 100% of all rebates and price protections for only a nominal added per member administrative fee.

Impact on Residents and Businesses

There is no direct impact to residents or private businesses in the County of Riverside.

Additional Fiscal Information

The current Agreement became effective October 1, 2018 for five (5) years. Approval of this action will extend the Agreement four (4) additional years and increase the cost by \$28,116 annually. Costs by Fiscal Year is as follows:

Administrative costs will only increase \$0.40 per member (\$2,343 per month or \$28,116 annually) with a projected increase in rebates of \$671,386 based on rebates received during calendar year 2021. Although rebates will likely be lower this year due to membership decline and decreased utilization, the net effect, however, will certainly be positive for the County Exclusive Care plan.

Contract History and Price Reasonableness

The Purchasing Department released a Request for Proposal (RFP) HRARC-069, soliciting proposals for Pharmacy Benefit Manager Services on behalf of the Human Resources Department on July 25, 2016. The RFP was sent to thirty-five (35) potential bidders and was advertised on the Purchasing website. Five (5) bidders responded to the RFP. Navitus Health Solutions was awarded as the lowest cost, most responsive and responsible bidder.

AMENDMENT NO. 1 TO PHARMACY BENEFIT MANAGEMENT SERVICES AGREEMENT

This Amendment No. 1 to Pharmacy Benefit Management Services Agreement is made effective as of October 1, 2021, between Navitus Health Solutions, LLC., a Wisconsin limited liability company ("Navitus"), and the County of Riverside, a political subdivision of the State of California ("Client").

WHEREAS, Navitus and Client have executed a Pharmacy Benefit Management Services Agreement dated October 1, 2018, as amended (the "Agreement");

WHEREAS, Navitus and Client desire to amend the Agreement as set forth below;

NOW THEREFORE, Navitus and Client agree as follows:

1. <u>Amendments to the Agreement.</u>

1.1. Article I. Definitions. The definition of Rebates is hereby deleted in its entirety and replaced with the following definition:

"Rebates means rebates or discounts received by Navitus pursuant to a contract with a pharmaceutical manufacturer, or intermediary (such as a group purchasing organization), and directly attributable to the Formulary and Covered Product utilization by Eligible Persons."

1.2. Article IV. Formulary Program and Rebates. The following is hereby added as a new Section 4.05:

Section 4.05. Group Purchasing Organization. Navitus will hold a limited number of direct contracts with pharmaceutical manufacturers. The majority of contracts with pharmaceutical manufacturers will be held through the group purchasing organization ("GPO") that Navitus contracts with for Rebates. Navitus will perform an annual audit of the GPO to confirm that: i) Rebates, manufacturer administration fees, and price protection were fully passed through to Client, ii) Rebates were invoiced and paid correctly, and iii) Rebate metric guarantees, if any, were met and calculated per the terms of this Agreement. Navitus will cooperate in good faith to obtain information from the GPO to the extent practicable under Navitus' contract with the GPO.

1.3. Article IX. Records; Confidentiality. Section 9.01 is hereby deleted in its entirety and replaced with the following:

Section 9.01. Maintenance of Records; Audits. Navitus agrees that it will provide Client with access to all of Navitus' books and records as may be reasonably required to audit Navitus' performance under this Agreement. Navitus agrees to maintain true and correct books and records of Client's Covered Product expenditures in the standard Navitus format and for a period of not less than seven years from the date payment is made. Client may audit such books and records, using an auditor and methodology that is selected by Client, provided that an auditor may not be a competitor of Navitus or an affiliate of a competitor, and Client shall reasonably consider input provided by Navitus related to the auditor and methodology used. Client may audit such books and records upon reasonable prior written notice and during Navitus' normal business hours consistent with privacy and other limitations of applicable federal and state laws, rules and regulations and the provisions of this Agreement. Client may only audit periods of service not more than 18 months prior to the date of such audit. The parties shall require any third-party auditor to execute a confidentiality agreement in a form that is reasonably acceptable to both parties, and which contains provisions intended to protect each party's Confidential Information that are substantially the same as the provisions set forth herein. Any release to the other party of records and data reviewed during such audit, whether electronically or in any other mutually agreeable format, will be in accordance with the terms of this Agreement and applicable law.

AMENDMENT NO. 1 TO PHARMACY BENEFIT MANAGEMENT SERVICES AGREEMENT

Notwithstanding the foregoing, Navitus acknowledges that state and federal rules, regulations and laws will govern audits conducted by regulatory agencies with jurisdiction over Client's Plan.

1.4. Article XII. Notice Regarding Renewal. Section 12.01 is hereby deleted in its entirety and replaced with the following:

Section 12.01. Term of Agreement; Initial Term and Renewal Term. This Agreement is effective as of the Go Live Date above and will continue in full force and effect for a period of one year ("Initial Term"). After the Initial Term has ended, this Agreement may be renewed for up to eight (8) additional subsequent one-year periods through September 30, 2027 (each, a "Renewal Term"), unless sooner terminated as described in Article VI of this Agreement or renewal is declined as set forth in Section 12.02 below. Any additional Renewal Terms shall be subject to termination rights as otherwise provided in this Agreement.

1.5. Exhibit 1. Administrative Services Fee Schedule. The following is hereby added to the end of Exhibit 1 as a new additional fee:

Client agrees to pay Navitus \$0.40 per Eligible person per month for Rebate administration fee. Navitus shall withhold the Rebate administration fee from Rebates received before being passed back to Client.

2. Other Terms. All other terms of the Agreement, which have not been expressly modified by this amendment, will remain in full force and effect.
