RECOMMENDED MOTION: That the Board of Supervisors:

- 1. Ratify and Approve Amendment No. 1 to the Professional Services Agreement between Riverside University Health System Behavioral Health (RUHS-BH) and the City of Palm Desert for Homeless Outreach Services effective July 1, 2022 through June 30, 2023 in the amount of \$168,000, with the option to renew through June 30, 2024; and
- 2. Authorize the Director of Behavioral Health, or his designee, to sign the Amendment on behalf of the County and to accept and sign documents related to the Agreement. This authority shall include signature of necessary renewals, documents, exhibits, certifications and reports, and non-substantive amendments that otherwise do not increase or modify the agreement through June 30, 2024. Renewal and Amendments shall be approved by County Counsel.

BACKGROUND:

Summary

Riverside University Health System – Behavioral Health (RUHS-BH) operates a continuum of care system, composed of County-operated clinics and contract service providers, delivering a variety of treatment services in each geographic region of the County.

On May 21, 2019, the Board of Supervisors approved Item 3.24 for RUHS-BH to enter into a Professional Services Agreement with the City of Palm Desert to provide behavioral health and homeless outreach services within the City of Palm Desert. The purpose and intent of the community collaborative between RUHS-BH and the City of Palm Desert is to allow RUHS-BH service staff to link homeless individuals to housing, behavioral health, substance use, and primary care services. This effort includes partnering with law enforcement and responding to calls for service involving homelessness and behavioral health issues. The City of Palm Desert wants to extend collaboration with the RUHS-BH homeless outreach team in order to decrease homelessness and adverse incidents involving mentally ill individuals within their city. RUHS-BH is requesting Board approval to continue on-going homeless outreach services through June 30, 2024.

Impact on Citizens and Businesses

These services are a component of RUHS-BH system of care aimed at improving access to care, and the health and safety of the community.

Additional Fiscal Information

The Professional Services Agreement will be funded by the City of Palm Desert and includes termination clauses in the event applicable Federal, State, and/or City funds become unavailable throughout the provision of services. The City of Palm Desert may extend the term of the Agreement for one (1) successive year at the discretion of the City of Council of the City of Palm Desert through June 30, 2024.

This program in the City of Palm Desert will be 100% funded by the City. No Additional County Funds are required.

AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF PALM DESERT AND THE COUNTY OF RIVERSIDE, RIVERSIDE UNIVERSITY HEALTH SYSTEM-BEHAVIORAL HEALTH

1 Parties and Date.

This Amendment No. 1 to the Professional Services Agreement dated the 24th day of June, 2021 is made and entered into as of this 12th day of May, 2022, by and between the City of Palm Desert ("City") and the County of Riverside, Riverside University Health System-Behavioral Health, a County in the State of California, with its principal place of business at 4080 Lemon Street, 5th Floor, Riverside, California 92501-3609 ("County"). City and County are sometimes individually referred to as "Party" and collectively as "Parties."

2. Recitals.

- 2.1 <u>Agreement</u>. The City and County have entered into an agreement entitled Professional Services Agreement dated the 24th day of June, 2021 ("Agreement" or "Contract") for the purpose of retaining the services of County to provide homeless outreach team services.
- 2.2 <u>Amendment</u>. The City and County desire to amend the Agreement to extend the term of the Agreement by one (1) year.
- 2.3 <u>Amendment Authority</u>. This Amendment No. 1 is authorized pursuant to Section 3.1.3 of the Agreement.

3. Terms.

3.1 <u>Term.</u> Section 3.1.2 of the Agreement is hereby amended in its entirety to read as follows:

"The term of this agreement shall be from July 1, 2022, to June 30, 2023 unless earlier terminated as provided herein. County shall complete the Services within the term of this Agreement, and shall meet any other established schedules and guidelines."

3.2 <u>Extension</u>. Section 3.1.3 of the Agreement is hereby amended in its entirety to read as follows:

"The City, at its option, may extend the term of this Agreement for one year at the discretion of the City Council of the City, by giving written notice of the exercise of such option to the County prior to June 30, 2023. In the event of the excise of such option by the City, all other terms of this Agreement shall remain the same, except for the new termination date in Section 3.1.2 thereof."

3.3 <u>Continuing Effect of Agreement</u>. Except as amended by this Amendment No. 1, all other provisions of the Agreement remain in full force and effect and shall govern the actions of the

parties under this Amendment No. 1. From and after the date of this Amendment No. 1, whenever the term "Agreement" or "Contract" appears in the Agreement, it shall mean the Agreement as amended by this Amendment No. 1.

- 3.4 <u>Adequate Consideration</u>. The Parties hereto irrevocably stipulate and agree that they have each received adequate and independent consideration for the performance of the obligations they have undertaken pursuant to this Amendment No. 1.
- 3.5 <u>Severability</u>. If any portion of this Amendment No. 1 is declared invalid, illegal, or otherwise unenforceable by a court of competent jurisdiction, the remaining provisions shall continue in full force and effect.
- 3.6 <u>Counterparts</u>. This Amendment No. 1 may be executed in duplicate originals, each of which is deemed to be an original, but when taken together shall constitute but one and the same instrument.
