BACKGROUND:

Summary

The Chief Probation Officers of California (CPOC), established in 1960, is a professional association of all 58 counties with a shared identity as law enforcement leaders. The mission of the CPOC association is to provide leadership in the mobilization, coordination, and implementation of Probation programs and provide for public protection including detention and treatment, victim services and the prevention of crime and delinquency; and to ensure the provision of quality investigations and supervision for the Courts. CPOC is committed to a research-based approach to public safety that promotes positive behavior change.

The CPOC annual dues are based on the population size of each participating county with counties designated as either small, medium, or large. CPOC dues support the entire CPOC structure from staff, operations, office space, subcontracts, lobbying, training, research and publications.

Based on its population size, Riverside County is designated as a large county. The FY2022-23 dues for Riverside County are \$77,441.46. Riverside County's participation in CPOC's statewide meetings, trainings, and oversight of programs are just a few benefits to the cost of the membership dues. Riverside County's Chief Probation Officer, Ron Miller, is a member of the CPOC Executive Committee and serves as the current Chair of the CPOC's Southern Region which includes Los Angeles, Santa Barbara, Orange, San Diego, San Bernadino, Imperial, and Ventura counties.

Impact on Residents and Businesses

CPOC's multi-dimensional approach to community safety includes holding clients accountable through community supervision, preventing crime by changing criminal thinking, objectively assessing the law and facts for individuals coming before the Court, restoring victims, and preventing future victimization. This includes rehabilitating clients with evidence-informed strategies that change their behavior and ensuring secure and effective detention services and successful reentry.
