BACKGROUND:

Summary

On May 25, 2021, Item 3.28, the Board of Supervisors (Board) approved in-principle and project budget of \$669,961 for the Sheriff Security Improvements Project. In the same Board action, the Board approved the construction contract between the County of Riverside (County) and Vincor through Easy Indefinite Quantity Construction (EZIQC) in the amount of \$619,939. This project was funded by CARES Act funding and was completed by the required date of December 31, 2021.

Several Sheriff's Department facilities were without proper security and needed enhancements to facilities to meet COVID-19 protocols. The scope of work for improvements and to provide security for staff and the public at multiple facilities, along with safeguarding Department assets included: installing anti-climb enclosures, automatic gates, and bullet resistant glazing window at the front counters. In addition, the reconfiguring of the Larry D. Smith Correctional Facility's main security control point provided better access into the facility while improving the monitoring access points.

Vincor has completed the work covered by CARES Act funding to satisfaction and the project has been inspected and found to comply with all contract requirements.

Impact on Residents and Businesses

The Sheriff Security Improvements Project enhances the safety and reduces the spread of COVID-19 in Department facilities for staff and the general public. Construction was scheduled to minimize any impact to the daily operations of the facilities.

Additional Fiscal Information

All costs associated with this Board action were previously approved on May 25, 2021 (Item 3.28) in the amount of \$669,961. Included in the project cost was Supplemental Work Order number 089421.01, a change order amount of \$20,285. The department had a credit from the contractor of \$133,069 resulting from descoping part of the project. The credit was applied

toward additional work to the perimeter fence to upgrade the security gates with new posts and systems. Once all the credit was applied for materials and the additional work, Supplemental Work Order Number 089421.01 totaled \$20,285. Based on all the invoices received and submitted to the Executive Office for payment, all the expenditures totaled \$613,826, which is of \$56,135 what was approved by the Board.



1. Upgrade gate operator to new HySecurity Slide Driver15 with groved aluminum drive rail and new UPS/DC battery backup system with all required supports, termination, and testing. Provide credit for the max control chain drive slide gate motor.

Any additional work due to unforeseen conditions will be treated as a supplemental to the work order.

Excludes any design, engineering, permit, and plan check related fees.

All work to be executed as per manufacturer's specifications and recommendations.

Prevailing wage rates shall apply.
