SUNDAY SEPTEMBER 18 2022 SURVEY'S RESULTS ABOUT GAS STATION IN FRONT OF ST CHRISTOPHER MYMAL CATHOLIC CHURCH AND PRESCHOOL

INTERSECTION OF COTTONWOOD AVE. AND PERRIS BLVD.

INTRODUCTION

St Christopher Parish and Pre-school has provided spiritual and pastoral care for the community during 65 years. We are about to celebrate our anniversary next month. We are facing lots of challenges such as vandalism, trespassing, loitering, break-ins and people from the streets coming inside the buildings to damage the property. This year 2022 a gas station with a potential of liquor and tobacco sale is getting build at the same corner Perris Blvd and Cottonwood Ave (Northeast) just in front of our parish. Our church is active 7 days a week. With the school and catechetical programs, the opening of this gas station will impact negatively our community. This Parish is where dozens of families attend for Mass and participate in dozens of ministries.

Research has shown that gasoline vapors and fumes, invisible but odorous, contain a number of toxic chemicals, notably benzene and lead, a carcinogen. Gasoline vapors permanent organ damage, cancer and birth defects/reproductive harm. Throat irritation, and the list keeps going on with other health issues or even death. Because of this HAZARD, our children and congregation are in danger.

HOW THIS SURVEY WAS CONDUCTED (PARTICIPANTS)?

A group of volunteers interviewed randomly people (of different ages and ethnicities) coming to Sunday Mass. We conducted this survey with the intention to collect data from parishioners about the impact of this gas station just in front of a place of worship and preschool. There was only one question we asked to all people interviewed: are you in favor this gas station? The options were: yes / no / I don't care and why (explaining the reason of your answer). We conducted this survey in both English and Spanish. Some parishioners gave us their personal opinion and input about this hazardous situation expressing that they want to participate in future social justice events/surveys.

ENVIRONMENTAL IMPACT RIVERSIDE COUNTY CODE AND MORENO VALLEY MUNICIPAL CODE

The City of Moreno and developers took advantage of the Covid-19 pandemic and planned without consulting the public about placing this gas station so close to St Christopher Catholic Church. After our research with regards the environmental impact of this gas stations, until this point, we have not heard about the disclosure of hazardous materials for this gas station, nor for oil company supplying the fuel. We found in the Riverside County code the following amendment/ordinance 651.5 (an ordinance of the county of Riverside amending ordinance no. 651 requiring disclosure of hazardous materials and the formulation of business plans incorporating by reference health and safety code chapter 6.95, sections 25500 et seq. and title 19 of the California code of regulations division 2, chapter 4.

SECTION 6. HAZARDOUS MATERIALS HANDLING CLASSIFICATION SYSTEM All hazardous materials reporting threshold shall be defined by Chapter 6.95 HSC unless otherwise stated in this Ordinance. A. Categories of Hazardous Material Inventory For purposes of permitting businesses pursuant to this Ordinance, categories of hazardous materials shall be as follows: 1. CATEGORY A a. Motor vehicle fuels stored in an underground tank system;

The City of Moreno Valley disregarded the fact of having thousands of people coming to the Church including children and giving permits to oil companies for the sake of "development". Reading through the Moreno Valley Municipal code, we did not find any criteria addressing the building of new gas stations. It is ironic that while the federal government is promoting renewable energy such us electric vehicles and alternative sources of power such as solar/wind energy, the leadership of this city is promoting the pollution of the environment so close to a place where a massive group of people gathers every week.

According to the EPA School Siting Guidelines "Building orientation and shading strategies and renewable energy technologies, such as geothermal heat pumps, wind turbines and solar panels, can help increase energy efficiency and reduce greenhouse gas emissions. EPA encourages local governments and communities to investigate and, where appropriate, integrate healthy high performance school or green school principles into their location selection and school planning and operation processes. Links to more information on green building (www.epa.gov/greenbuilding)" (p.37). It is ironic that while the federal government is promoting renewable energy such us electric vehicles and alternative sources of power such as solar/wind energy, the leadership of the City of Moreno Valley is promoting the pollution of the environment so close to a place where a massive group of people gathers every week.

Why city leaders and developers of new gas stations do not take into the considerations the recommendations of the federal government? New schools supposed to be at least 1000 feet from the nearest gas station. Should a new gas station consider 1000 feet to be reciprocal? When we see the lack of common sense in this decision that led to the building of this facility we came to know that it is not fair for the community.




Looking at this map, we can see that in the diagonal between the gas station and the preschool is a little over 300 feet. The whole length of the street is 71 feet each sidewalk is 9 feet, adding up to 89 feet from the property of the gas station to the church's campus. From the gas station to the doors of the church is 198 feet. Considering what is known in proposition 65 about cancerogenous gas fumes, we want to know if the gas station company will be liable and it will cover the bill and the health complication parishioners will face. Is the gas station company providing 24/7 security for the surroundings of the parish. Parishioners would feel unsafe and health issues is another risk in the near future due to the close proximity of this gas station. We know by the fact that wind is blowing most of the time from north to south in the City of Moreno Valley meaning that gas vapors will enter our church and bring poor air quality to our congregation. As we can see in this picture, there is another gas pump just next to church

property, so we will literally sandwiched in between two gas stations.



SURVEY'S DATA AND STATISTICS

This survey interviewed a total of 180 parishioners. Out of the 180, the overwhelming majority (173) 96.1% expressed that they are against this gas station. Only 3 (1.6%) people were in favor and 4 (2.22%) of them said that they "do not care".



96.1% against the gas station

1.6% in favor of the gas station

2.22% do not care

Our survey demonstrated that the concerns of our people are not taking into consideration by the city authorities. Crime is already rampart in and around the parish property. During the covid-19 pandemic there were at least three incidents of break ins during the Covid pandemic into the priest rectory. Homeless individuals have entered the property causing vandalism, saying bad words to parishioners and being confrontational. City police is not patrolling enough out neighborhood, even though they fill sheriff vehicles' tanks just next door of the parish.

By having this gas station crime will skyrocket as research has shown that there is more crime in around gas stations. According to Gotham and Kennedy, "Police departments and others have long characterized convenient stores as "stop and rob" referring to how criminals can supposedly easily and often rob convenience stores".

The answers of the people participating in this survey about the question (why you are against this gas station?) are the following:

More insecurity and crime. More encounters with homeless who are under the influence. People were worrisome about the potential selling of alcohol and tobacco that will impact negatively the whole neighborhood. Other people expressed that there are already too many gas stations around. Considering that this is already a busy intersection, traffic issues will increase dramatically. Ecological and environmental impact as the gas fumes will pollute more the environment a this is an area where bad air quality is on the rise.

People also expressed that they are scare because the risk of fire increase where a gas station is located along with the chemical hazards that are known through California proposition

65. Some people express that the odor and the proximity of this gas station will impact their participation at church as parishioners will be distressed by the noise contamination and traffic. Coming to church will become a distressful experience.

The fact that we have a pre-school and children come for faith formation is a great concern for parent as their kids will be more exposed to contamination and toxic substances.

Worship God supposed to be in silence and tranquility. This gas station will disturb greatly the way people express their faith.

In the bible we find that

For the creation waits with eager longing for the revealing of the sons of God. For the creation was subjected to futility, not willingly, but because of him who subjected it, in hope that the creation itself will be set free from its bondage to corruption and obtain the freedom of the glory of the children of God. For we know that the whole creation has been groaning together in the pains of childbirth until now Romans 8:19-22 ESV

As Christians, we need to take care of the environment and our neighbor as well always looking for the common good.

With regards the few that were in favor of the gas station (1.6%), they said that it was convenient for them to get gas. The 3 individuals who responded this way were young adults.

People who did not care about having this gas station so closed, expressed that they just did not think it was a hazard or they though "it does not affect the environment". Only one person responded that he was in favor of the gas station with the condition that they do not sell alcohol or tobacco.

As Christians, we need to take care of the environment and our neighbor as well always looking for the common good. Pope Francis reminds us to take care of our environment in a "throw away culture" by action. We are practicing the Gospel by protecting our sacred places and our neighborhood from toxic substances. We will keep this movement growing. Pope Francis also prays with canticle of the creature composed by St Francis of Assisi, patron saints of animals and environment:

Praised be you, my Lord, with all your creatures, especially Sir Brother Sun, who is the day and through whom you give us light. And he is beautiful and radiant with great splendor; and bears a likeness of you, Most High. Praised be you, my Lord, through Sister Moon and the stars, in heaven you formed them clear and precious and beautiful. Praised be you, my Lord, through Brother Wind, and through the air, cloudy and serene, and every kind of weather through whom you give sustenance to your creatures. Praised be you, my Lord, through Sister Water, who is very useful and humble and precious and chaste.

May the Lord help us to be good stewards of our resources and our common home: the earth.
