Mike also investigated a murder in the Amazon, and a toxic explosion at a chemical plant. He even swam with humpback whales.

Mike was a Writer-in-Residence at the Cary Institute for Ecosystem Studies in Millbrook, New York, and a Media Fellow at the Nicholas School of the Environment and Earth Sciences, Duke University. He produced three books, and several hundred scholarly articles in journals like Discover, Scientific American, New Scientist, National Wildlife, Audubon, Science, and Smithsonian.

Mike was an active member of Homeowners, he sat on the Board of the Community Council, and he was a member of the California Turtle & Tortoise Club. He loved Sky Valley ever since acquiring the old Clancy Allen place in the summer of 2010. He always wanted to be of service and to protect the desert. He was a faithful watchdog over all the beauty he found in the Desert.

Mike's memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.
