#### **BACKGROUND:**

## Summary:

The Riverside County Advisory Council on Aging ("Council") is the local official Area Advisory Council, as mandated by the Federal Older Americans Act and the State Older Californians Act. The Council is a volunteer leadership body whose purpose is to advise the Office on Aging and the Board of Supervisors on matters related to the development of the Office on Aging Area Plan ("Plan"), the administration of the Plan, and operations conducted under the Plan. Pursuant to the Council's bylaws, Council membership shall consist of seventeen (17) members and be composed of: (1) a majority of persons sixty (60) years of age or older, (2) service providers, (3) members who reflect the Districts established by the Board of Supervisors or the geographic, racial, economic, and social complexities of the planning and service area, (4) at least one member who represents the interests of the disabled, and (5) the Director of the Office on Aging, or his/her designee, who shall serve as an ex officio member. Each member shall be a resident of Riverside County or be employed within the county. The term of office of members shall be for a three (3) year period, commencing on the first day of July, or if appointed at any other time rather than July 1st to fill a vacancy, the term shall be considered as a full three-year term if appointed prior to the mid-point of the vacancy to which the member is appointed. If the appointment is after the mid-point, the term shall not be considered a full term and the member shall be eligible to serve one full term following this appointment to fill a vacancy.

Since September 18, 2018, Mr. Javier Lopez has served Supervisor V. Manuel Perez as the Fourth District's Advisory Council on Aging representative. As Mr. Lopez no longer resides in the Fourth District, he has requested to be appointed to the Advisory Council on Aging as a general member.

The Membership Committee of the Advisory Council on Aging reviewed and recommended Mr. Lopez's appointment as a general member to the full Advisory Council on Aging, which then approved the appointment on June 8, 2022. Mr. Lopez represents the residents of Riverside County; reflects the districts established by the Board of Supervisors and the geographic, racial, economic, and social complexities of the planning and service area; and is representative of supportive services providers for older adults.

In accordance with Board Policy A-21, Resolution No. 2005-148, Uniform Rules and Procedures for Advisory Committees, Boards and Commissions of the County of Riverside, and the Council's bylaws, the Office on Aging and the Advisory Council on Aging respectfully request the Board of Supervisors appoint Javier Lopez to the Riverside County Advisory Council on Aging for the period of July 1, 2022, through June 30, 2025, commencing on October 4, 2022, and terminating on June 30, 2025.

## **Impact on Residents and Businesses**

The Riverside County Advisory Council on Aging is a diverse group of seasoned community leaders who are committed to identifying relevant issues, recommending solutions, and advocating for positive change on behalf of Riverside County older adults, persons with disabilities, and caregivers.
