BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **Riverside Medical Clinic Charitable Foundation- \$2,000** funding will be used to provide training to educators, law enforcement, youth leaders, and community representatives who are committed to ending bullying.
2. **Riverside County Foundation on Aging - \$3,000** funds will be used to assist the Foundation with their Holiday Gift Program. Through this Program, seniors are selected from each senior center in the 1st District to receive a Stater Bros. gift card to be used for the holidays. Gift cards will be purchased and distributed as follows: Lake Elsinore, Wildomar, Arlanza, Good Hope, Mead Valley, La Sierra, Stratton, Ysmael Villegas.
3. **Janet Goeske Foundation- \$5,000-** funding will be used to support comprehensive programs and services for adults who are 50 and older in the First District.
4. **Martin Luther King High School, "King High Remembers" - \$1,500** funding will be used to provide assistance with costs of the King High Remembers program, a Veterans Oral History Project.
5. **Restoration Agape - \$5,000** funding will be used to support the Fall Festival and Christmas Festival of Lights events at the Moses Schaffer Community Center in Good Hope.
