

BACKGROUND:

Summary

The Political Reform Act prohibits a public official or employee from using his or her position to influence a government decision in which he or she has a financial interest. Government Code section 87300 requires local government agencies to adopt and promulgate a Conflict of Interest Code identifying officials and employees required to file statements of economic interest based on the positions they hold. A local government agency, as defined by Government Code section 82041, includes the County of Riverside.

The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations section 18730) that contains the terms of a standard conflict of interest code, which may be incorporated by reference in a local government agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. The County of Riverside has incorporated 2 California Code of Regulations Section 18730 and any amendments duly adopted by the Fair Political Practices Commission in its conflict of interest code. This regulation and the Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside, designating positions and establishing disclosure categories, constitutes the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside.

Each even-numbered year, Government Code Section 87306.5 requires the County of Riverside to review its Conflict of Interest Code and make appropriate revisions, if necessary. Such revisions include adding new positions, revising disclosure categories, revising the titles of existing positions, and deleting titles of positions that have been abolished and/or positions that no longer make or participate in making governmental decisions. Each department, agency, board, commission, committee, and council listed in the Appendix of the Conflict of Interest Code for the County of Riverside has reviewed its list of designated positions and disclosure categories. The Office of County Counsel has reviewed the Code as whole and made changes throughout the Code for clarity and consistency. These changes include alphabetizing the renamed departments and positions and assigning all positions with the same Human Resources Code the same disclosure category throughout the various departments. Where a

position is designated for full disclosure, numbers 1 through 7 have been written out rather than simply using "1" to identify full disclosure. Certain boards, committees, commissions, or councils that have been dissolved or listed in other agencies' conflict of interest codes have been removed from the Appendix, and after review of the duties of all of these bodies, those which have been determined not to meet the requirements to warrant financial disclosure have been listed as exempt. Attached is a redline version and a clean version of the proposed amended Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside with the above mentioned departments, agencies, boards, commissions, committees, and councils changes to its list of designated positions and disclosure categories.

The Political Reform Act requires the adoption of any amendments to a local government agency's conflict of interest code to be carried out under procedures that guarantee to officers, employees, members, and consultants of the agency and to residents of the jurisdiction adequate notice and a fair opportunity to present their views. Prior to the Board adopting the amended Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside, the Fair Political Practice Commission recommends a 45-day comment period and a public hearing.

It is recommended that the Board of Supervisors set a public hearing on or after December 6, 2022 regarding the proposed amended Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside. In addition, it is recommended that the Board of Supervisors authorize and direct the Clerk of the Board to place an advertisement for the public hearing in the appropriate local publications and notify each affected designated official or employee. After the close of the public hearing, it is recommended that the Board of Supervisors adopt Resolution No. 2022-194, A Resolution of the Board of Supervisors of the County of Riverside Adopting an Amended Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside.

8 and local government agencies adopt and promulgate conflict of interest codes; and

9 WHEREAS, the Fair Political Practices Commission has adopted a regulation, 2 California Code
10 of Regulations, section 18730, which contains the terms of a standard conflict of interest code, which may
11 be incorporated by reference in a local government agency’s code, and which may be amended by the Fair
12 Political Practices Commission to conform to amendments in the Political Reform Act; and

13 WHEREAS, the Board of Supervisors of the County of Riverside, State of California, adopted the
14 provisions of 2 California Code of Regulations, section 18730, and any amendments to it as adopted by
15 the Fair Political Practices Commission, with an Appendix in which certain enumerated officials and
16 employees and members of certain enumerated boards, commissions, committees and the Grand Jury are
17 designated and disclosure categories are assigned, to constitute the Conflict of Interest Code for
18 Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside
19 (“Conflict of Interest Code”); and

20 WHEREAS, the Board of Supervisors on December 15, 2020, adopted Resolution No. 2020-175
21 amending the Appendix of the Conflict of Interest Code; and

22 WHEREAS, changed circumstances within the County have made it advisable and necessary
23 pursuant to Section 87306 and 87307 of the Political Reform Act to amend and update the Appendix of
24 the Conflict of Interest Code; and

25 WHEREAS, notice of time and place of a public hearing on, and of consideration by the Board of
26 Supervisors of, the proposed amended Appendix was provided to each affected designated official or
27 employee, publicly posted for review at 4080 Lemon Street, Riverside, California, and duly published in a

12 his or her own statement with the Clerk of the Board of Supervisors. Consultants, members of boards,
13 commissions, committees and members of the Grand Jury shall file their statements directly with the
14 Clerk of the Board of Supervisors. Statements shall be filed by April 1 of each year to reflect interests
15 held in the prior calendar year.
