

**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. The Coachella Valley Housing Coalition’s (CVHC) mission is to improve the living conditions of low-income individuals and families by constructing and operating affordable housing infused with community services, programs and other opportunities. CVHC is celebrating their 40<sup>th</sup> Anniversary Gala, funds will be used to support the Resident Services Department’s activities, including Afterschool Programs.
  
2. Eventscape International Inc. will host the 9<sup>th</sup> Annual Run with Los Muertos on November 5, 2022. The event collaborates with dozens of local agencies as well as international artists to provide art, culture, health and educational opportunities that celebrate the day of the dead holiday. CID funds will be used on equipment and supplies for the build out of Run with Los Muertos.
  
3. The Rotary Club of Palm Desert Foundation is hosting Imagine the Possibilities District 5330 Foundation Gala, featuring keynote speaker Rotary International President Jennifer Jones. Funds will be used to invite students from the Coachella Valley to attend.
