# BACKGROUND: Summary

On June 16, 2015, Item 3-26, the Board of Supervisors (Board) approved the construction contract between the County of Riverside (County) and Clark Construction Group-California, LP (Clark Construction) in the amount of \$274,917,000; approximately \$18,000,000 (6.5%) lower than the bid submitted by the second low bidder. During construction, a total of 55 change orders were issued; 12 deductive change orders and 43 additive change orders in the cumulative amount of \$27,811,024 for a net contract value of \$302,728,024.

To allow the Sheriff's Department to transition into the facility while not affecting inmate capacity, the JJB Detention Center Project was split into two phases:

- Phase I Construction of new housing buildings with 1,626 beds, a multi-level support building, site power, public entrance, and a secure tunnel connecting to holding cells in the Larson Justice Center. On June 23, 2020, Item 3.12, the Board approved the Phase I Notice of Completion for Clark.
- Phase II Demolition of the existing 353-bed jail and construction of a new sally-port, additional parking, and landscaping. The Certificate of Occupancy was issued on July 16, 2021, and the JJB Detention Center was occupied and fully operational.

Change Order No. 56 will compensate Clark Construction in the amount of \$4,304,932, for a new contract value of \$307,032,956. The change order amount exceeds Facilities Management's (FM) change order authority; therefore, FM is seeking Board approval. This Change Order No. 56 constitutes full and final resolution, settlement, accord and satisfaction of any and all remaining change order requests and claims by Clark Construction in connection with the Project.
