BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The donation to **Fit One Foundation** will be used to continue their mission to reach Second District residents with free health, fitness and nutrition classes and focus on their specific goal to help underserved children and youth. Also, to continue Kid's Camps at their Community Fitness Center.
2. The donation to **The Rotary Club of Greater Eastvale** will help them continue to fund their Rotary Youth Leadership Awards which is an intensive leadership experience organized by Rotary clubs and districts where youths ages 14-18 develop skills as a leader. Build communication and problem-solving skills, discover strategies for becoming a dynamic leader in the school or community. Rotarians plan and carry out a variety of humanitarian, educational, and cultural exchange programs.
3. The donation to the **Janet Goeske Foundation**, a senior center, will help run their Comprehensive Senior Programming Services (CSPS). One of the services offered is Senior Advisor, seniors receive one-on-one personal attention and assistance in resolving issues and navigating complex processes. CSPS also includes nutrition programming, health education as well as physical fitness programs to help seniors eat better and live a healthier lifestyle. Funding will be used for development of new Senior Services Programs as well as the enhancement and expansion of current Senior Services into surrounding areas.
4. The donation to **Reach Out** will be used to fund Healthy Jurupa Valley (HJV). HJV benefits Jurupa Valley by working to make the healthy choice the easy choice and is recognized as a local model of healthy community work. HJV aims to support health and well-being at all levels.
