

**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. **Community Outreach Ministry - \$1,000** funds will be used to support their Annual Angel Tree Christmas Tree Project which will provide food and clothing to 200+ at-risk and/or needy children (ages 0-18) whose parents are incarcerated, as well as provide them with a holiday meal.
2. **Daughters of Love, Inc - \$2,500** funds will be used to assist in providing transitional housing for pregnant and/or parenting women ages 18-21.
