BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The donation to **ABC Hopes, Inc.** will be used for the 2022 Cornhole Tournament and the 2023 Casino Night which the funds from these events benefit the community to better the lives of persons with intellectual disabilities through the development of social, physical and life skills programs.
2. The donation to **Daughters of Love, Inc.** will be used to help provide transitional housing for pregnant and/or parenting women ages 18-21 who have aged out of foster care but are still in need of resources to obtain independent living within Riverside County.
3. The donation to **Allen Chapel African Methodist Episcopal Riverside** will help provide food, clothing for homeless for the holidays or the underserved population within Riverside County.
4. The donation to **Jurupa Valley High School Theatre Company** will help fund much needed equipment, lighting, audio, etc. instead of renting. The program operates solely from funds that were made from ticket sales and fundraising and they are lacking basic and advanced equipment, meaning they are constantly renting equipment. They have slowly been making strides to purchase more permanent equipment that is appropriate for their small stage.
