



BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Beaumont Community Chamber of Commerce - \$10,000: Funding will be used to support the projects and programs at the Beaumont Chamber of Commerce as they continue to offer businesses support to enhance their success throughout the community and educate Pass Area residents and business owners.
2. Banning Chamber of Commerce - \$10,000: Funding will be utilized to support community outreach and support programs and activities through business and community development.
3. Calimesa Chamber of Commerce - \$10,000: Funding will be used to support projects to help local businesses connect through resources, educational programs, and scholarships to local high school graduates to pursue higher education.
4. Riverside County Foundation on Aging - \$5,000: Funding will be used to support the nutrition needs of Riverside County seniors through gift cards from grocery stores to purchase food, medicine, and services for daily living needs.
5. Loving Me 1st - \$7,500: Funds will be used to support the Girls Club which serves youth in Moreno Valley through mentorship and various events geared towards self-esteem building, community events, and scholarships to support young women pursuing higher education.
6. Power Speaks Louder - \$10,000: Funds will be utilized to support community outreach programs such as the Free Food Drive Thru which targets low-income families providing perishable and non-perishable food items as well as their street outreach program which serves the general homeless population throughout Moreno Valley.
7. Ramona Bowl Amphitheatre - \$10,000: Funding will continue to support the regional

center for arts in the San Jacinto Valley by educating the community through music, arts, and educational programs and maintaining the preservation of the historical outdoor play.
