BACKGROUND:

Summary

Over the years, Riverside University Health System – Public Health's (RUHS-PH) capital assets were decommissioned and sent to county surplus. In some cases, all signatures were not obtained making it difficult to send to the Auditor-Controller's Office (ACO) to be discharged. Branch Managers have confirmed that the assets are no longer in the department's possession.

Over the last year, RUHS-PH staff has worked with County Purchasing and the ACO to complete these write-offs. RUHS-PH has since implemented policies and procedures and has provided the necessary training in order to meet ACO requirements for all capital assets.

Attachment A provides a detailed listing of the items RUHS-PH recommends being written off. The table below summarizes Attachment A.
