SUBJECT: RIVERSIDE UNIVERSITY HEALTH SYSTEM – MEDICAL CENTER: Ratify and Approve the First Amendment to the Professional Service Agreement with CHG Companies, Inc. dba CompHealth for Physician Locum Tenens Coverage Effective October 18, 2022 through June 30, 2023, All Districts. [Total Amendment Cost \$1,300,000; up to \$200,000 in Additional Compensation Annually] 100% - Hospital Enterprise Fund 40050

RECOMMENDED MOTION: That the Board of Supervisors:

1. Ratify and Approve the First Amendment to the Professional Service Agreement with CHG Companies, Inc. dba CompHealth, for Physician Locum Tenens Coverage to increase the contract amount by \$1,300,000 from \$700,000 to \$2,000,000 effective October 18, 2022 through the current termination date of June 30, 2023 and authorize the Chair of the Board to sign the amendment on behalf of the County; and
2. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, based upon the availability of funding and as approved by County Counsel, to sign amendments that do not change the substantive terms of the agreement and to sign amendments to the compensation provisions that do not exceed the sum total of ten percent (10%) of the total annual cost of the contract.

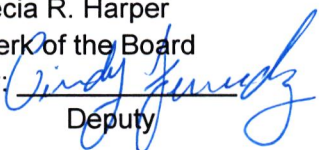

BACKGROUND:

Summary

The requested Board action will approve the First Amendment to the Professional Service Agreement between Riverside University Health System – Medical Center (RUHS-MC) and CHG Companies, Inc. dba CompHealth, to increase the contract amount by \$1,300,000 from \$700,000 to \$2,000,000. This Amendment will ensure that adequate funding is in place to provide the necessary staffing of physicians through the end of this fiscal year, thereby allowing RUHS-MC the ability to meet the healthcare needs of all patients.

RUHS-MC has consistently experienced high patient volumes for the past three years, which has resulted in increased challenges maintaining demanded levels of physician staffing within its inpatient and critical care units. This Amendment will continue to allow RUHS-MC to utilize the additional physician staffing resources made available by CompHealth to meet those challenges.

Impact on Residents and Businesses

These services are a component of RUHS's system of care aimed at improving the health and safety of its patients and the community.

Additional Fiscal Information

There are sufficient funds in the Department's budget for FY 22/23 to cover this proposed increase and no additional County funds are required.

Contract History and Price Reasonableness

On August 5, 2022, the Purchasing Agent executed a Professional Services Agreement for Physician Locum Tenens Coverage with CHG Companies, Inc. dba CompHealth effective August 5, 2022, through June 30, 2023, not to exceed the annual amount of \$700,000.

This Amendment requires Board approval as the compensation provision exceeds the Purchasing Agent's authority and \$750,000 threshold for contracting with a single vendor per Resolution 2021-116, Agenda Item 3.22, June 15, 2021.

**FIRST AMENDMENT TO THE PROFESSIONAL SERVICE AGREEMENT
FOR
PHYSICIAN LOCUM TENENS COVERAGE
BETWEEN
COUNTY OF RIVERSIDE
AND
CHG COMPANIES, INC. DBA COMPHEALTH**

This First Amendment to the Professional Service Agreement for Physician Locum Tenens Coverage (herein referred to as "First Amendment") is made and entered into by and between the **County of Riverside**, a political subdivision of the State of California (herein referred to as "COUNTY"), on behalf of **Riverside University Health System Medical Center** (herein referred to as "RUHS"), and **CHG Companies, Inc. dba CompHealth**, a Delaware corporation (herein referred to as "CONTRACTOR"), sometimes collectively referred to as the "Parties" or individually referred to as a "Party."

WHEREAS, COUNTY and CONTRACTOR entered into that certain Professional Service Agreement for Physician Locum Tenens Coverage, dated July 1, 2022, (herein referred to as "Agreement"); and

WHEREAS, the Parties now desire to correct the entity name for RUHS and increase the contract maximum amount of the Agreement;

NOW THEREFORE, the Parties agree as follows:

1. The correct entity name for RUHS is Riverside University Health System Medical Center.
2. **Compensation.** The second sentence of subsection 3.1 of Section 3. Compensation is hereby deleted in its entirety and replaced with the following:

"Maximum compensation payable under this Agreement by COUNTY to CONTRACTOR shall not exceed two million dollars (\$2,000,000) per County fiscal year, including all expenses."

3. The first sentence of Exhibit A Section 11.0 is hereby deleted in its entirety and replaced with the following:

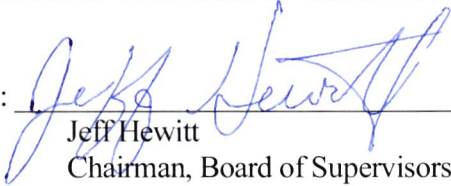
"Maximum compensation payable under this Agreement by COUNTY to CONTRACTOR shall not exceed two million dollars (\$2,000,000) per County fiscal year, including all expenses."

4. **Miscellaneous.** All other terms and conditions of the Agreement not modified herein shall remain unchanged and in full force and effect.

5. **Effective Date.** This First Amendment to the Agreement shall become effective October 18, 2022.

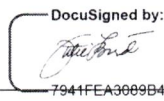
