

**SUBJECT:** REGISTRAR OF VOTERS: Ratify and Approve Amendment No. 1 with Consolidated Printers, Inc. to provide Sample Ballot Printing and Mailing Services from August 23, 2013 to August 23, 2023 for the amount of \$2,000,000 annually, Second Amendment with Dominion Voting Systems to provide Software Licenses and Maintenance from June 18, 2019 to July 1, 2029 for the total \$14,969,056, and Amendment No. 1 with Runbeck Election Services Inc. to provide Official Ballot Printing and Mailing Services from March 1, 2018 to June 30, 2023 for the total amount of \$2,715,000; All Districts. [Total Cost \$19,684,056 additional compensation not to exceed 20% of each contract aggregate; 38% General Fund, 62% State Reimbursement & Local Jurisdiction Reimbursement]

3. Ratify and Approve Amendment No. 1 with Runbeck Election Services to provide Official Ballot Printing and Mailing Services from March 1, 2018, to June 30, 2023, for the total amount of \$2,715,000;
4. Authorize the Chairperson of the Board to sign three (3) copies of the same for each Amendment;

Authorize the Purchasing Agent, in accordance with Ordinance No. 459, based on the availability of fiscal funding and as approved by County Counsel, a) to sign amendments to the renewal options that stay within the intent of the Agreement, and b) to increase the compensation not to exceed 20% of each contract aggregate for optional future purchases for the term of the Agreement; and
6. Direct the Clerk of the Board to retain one (1) copy of each Agreement and return two (2) copies of each Agreement to the Registrar of Voters for distribution.



**BACKGROUND:**

**Summary**

**Consolidated Printers (RFP# RVARC-011; RVARC-96600-001-08/14)**

On December 1, 2011, Purchasing released a Request for Proposal (RFP) for sample ballot printing and mailing services. A total of two vendors responded to the RFP and upon review, Consolidated Printers was the lowest, responsive bidder, and recommended for award. On September 13, 2013, an Agreement between Riverside County and Consolidated Printers was executed.

Approving Amendment No. 1 for Consolidated Printers will allow the performance period to be extended through August 23, 2023, to pay remaining invoices for November 2022 election related services. Factors contributing to increased expenditures include increases in the number of registered voters and the quantity and types of sample ballots as a result of redistricting and local jurisdictions changing from voting at large to voting by district.

**Dominion (RVARC-93690-001-05/27)**

On June 18, 2019, (Agenda Item 3.37), the Board approved the Managed Services Agreement between the Registrar of Voters and Dominion Voting Systems, Inc. for the purchase of voting system services and software use licenses. The Dominion Voting System, Inc. was implemented by the Registrar of Voters in November 2019. With this system implementation Riverside County met the compliance standards of the California Secretary of State decertification mandate. The original agreement with Dominion is based on piggybacking from the County of Sacramento agreement with Dominion for voting equipment and services which was awarded through a publicized competitive bid process. At that time, the County was able to negotiate an additional 2% discount from Sacramento's 28% off list to a Riverside County discount of 30% off list price. Piggybacking off of another competitively bid governmental procurements meets the county's requirement of seeking competition and assists with expediting the implementation/acquisition of needed commodities and services.

On August 24, 2021, (Agenda Item 3.26), the Board approved the First Amendment to increase the number of ICX electronic touchscreen ballot marking devices from 700 to 850.

Approving the Second Amendment for Dominion Voting Services will allow for the lease of additional equipment so that Registrar of Voters may fully implement the Voter's Choice Act election model.

**Runbeck (RFP# RVARC-020; RVARC-96600-001-03/22)**

On November 15, 2017, Purchasing released a Request for Quote (RFQ) for official ballot printing and mailing services. The bid was restricted to bidders that have been approved and or certified by the Secretary of State to provide official ballot printing and mailing services.

A total of three vendors responded to the RFQ and upon review Runbeck Election Services was the lowest, responsive bidder and recommended for award. In March 2018, an agreement between the County of Riverside and Runbeck Election Services was executed.

Approving Amendment No. 1 for Runbeck, Inc. will allow the performance period to be extended through June 30, 2023, to pay remaining invoices for November and December 2022 election related services. Additionally, monies are allocated should ROV have to conduct an unscheduled local election in 2023.

**Impact on Residents and Businesses**

The continued use of the aforementioned services allows for the Registrar of Voters to meet the growing needs of the County and be in accordance with election code.

**Additional Fiscal Information**

The Registrar will submit a budget adjustment request as part of the Mid-year budget cycle to cover the additional expenses.

The Secretary of State has notified the Registrar that as of 2024, reimbursement of 75% for voting system replacement expenses will no longer be provided. The Secretary of State has not provided additional information regarding future reimbursement plans. As of FY 25/26, it is expected that all voting system expenditures will be funded by NCC, unless the Secretary of State renews the funding match.

**SECOND AMENDMENT  
MANAGED SERVICES AGREEMENT  
BY AND BETWEEN  
DOMINION VOTING SYSTEMS, INC. AND RIVERSIDE COUNTY, CA**

This Second Amendment to the Managed Services Agreement is made and entered into as of this 15<sup>th</sup> day of October 2022 (the "Second Amendment Effective Date") between Riverside County, CA ("Customer") and Dominion Voting Systems, Inc. ("Dominion").

**RECITALS**

**WHEREAS**, on June 1, 2019, the Customer and Dominion entered into a Managed Services Agreement (the "Original Agreement"); and

**WHEREAS**, on July 1, 2021, the Customer and Dominion entered into a First Amendment to the Managed Services Agreement ("First Amendment") (collectively, the Original Agreement and First Amendment are referred to herein as the "Agreement");

**WHEREAS**, the Customer and Dominion would like to modify the terms of the Agreement.

**THEREFORE**, in consideration of the mutual covenants and obligations herein contained, and other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Customer and Dominion agree as follows:

**AMENDMENT**

**1 Recitals Incorporated.** The above recitals are true and correct and incorporated herein by this reference as if fully set forth.

**2. Replacement of Exhibit A.** Exhibit A-1 to the Agreement is hereby deleted in its entirety and replaced by Exhibit A-2 attached to this Second Amendment.

**3. Amendment of Section 3 of Agreement.** Section 3 of the Agreement is amended to read in its entirety:

**"Term of Agreement.** The Term of this Agreement shall begin on the Effective Date and shall continue until June 30, 2029."

**4. All Other Terms.** Except as expressly amended in this Second Amendment, the Agreement shall remain in full force and effect.

**1.1 Pricing and Payment Summary.** The annual Agreement pricing shall equal the amounts described below in this section 1.1 for the eight (8) years. All prices are in USD. ### 3. Detailed Deliverables Description

3.1 **ImageCast® Central Scanner (ICC) with interScan HiPRO Series high speed scanner.** Dominion shall provide the ImageCast® Central Scanner for use by the Customer. The ImageCast® Central Scanner is commercial off-the-shelf digital scanners configured to work with the ImageCast® Central Software for high speed ballot tabulation. Each ImageCast® Central Scanner includes the following components:

- 3.1.1 interScan HiPRO Series high speed scanner.
- 3.1.2 ImageCast® Central Software
- 3.1.3 OptiPlex 3050 All-in-One Series with pre-loaded software
- 3.1.4 iButton Security Key
- 3.1.5 iButton Programmer and iButton Key Switch & Cat5 RJ 45 Cables used with Democracy Suite to transfer security and election information to the iButtons for use with the ICC.

- 3.2 **ImageCast® Software.** The Dominion software includes, without limitation:
- 3.2.1 **AuditMark®.** For each ballot that is scanned and accepted into the unit, a corresponding ballot image is created and stored for audit purposes. The image consists of two parts described below.
- The top portion of the image contains a scanned image of the ballot.
  - The bottom portion consists of a machine-generated type-out showing each mark that the unit interpreted for that particular ballot. This is referred to as an AuditMark®.
- 3.3 **ImageCast® X (“ICX”).**
- 3.3.1 **Application:** ImageCast X BMD is a touchscreen in-person voting device and ballot marking device. Voting sessions are initiated on the tablet by either a smart card or the entry of a numeric code based on activation. The ballot is loaded directly onto the standalone device. All voting activity is performed at the tablet, including accessible voting. Accessible voting interfaces connect to the tablet via an Audio Tactile Interface or ATI. For all modes of voting, after the voter reviews the ballot selections, a paper ballot is created for the voter from a printer in the voting booth. The printed ballot contains a written summary of the voter’s choices, as well as a 2D barcode which is read by Dominion’s ImageCast Precinct or Central tabulator. No votes are stored on the ImageCast X-BMD unit. All votes can be tabulated and stored on the ImageCast Central.
- 3.3.2 **Components:** ImageCast X BMD is composed of a 21” Avalue touchscreen, Android OS 4.4.4, DC 19V input, HP LaserJet Pro M402dne laser printer, 6’ cable, 5 smart cards, and 8GB flash drive.
- 3.4 **Democracy Suite Light Software** consists of the following components:
- 3.4.1 **Election File and iButton Creation** Customer is authorized to create Election Files and iButtons from EED to load on the ICX, ICVA and ICC units.
- 3.4.2 **Results Tally and Reporting (RTR) Client Application** is the application used for the tally, reporting and publishing of election results.
- 3.5 **ImageCast® Adjudication Application** is a client and server application used to review and adjudicate ImageCast® Central Scanner ballot images. The application uses tabulator results files and scanned images to allow election administrators to make adjudications to ballots with auditing and reporting capabilities. The Adjudication Application examines such voter exceptions as overvotes, undervotes, blank contests, blank ballots, write-in selections, and marginal marks. The application works in two basic modes: election project setup and adjudication. The Adjudication Application can be used in a multi-client environment.
- 3.6 **Implementation Services and Training.** Dominion will provide the following training as described herein.
- 3.6.1 **Project Management Support.** Dominion will provide project management

support to oversee the general operations of the project through the Agreement Term. The project manager shall be responsible for arranging all meetings, visits and consultations between the parties and for all administrative matters such as invoices, payments and amendments. The Parties shall develop and finalize a project implementation plan including a training and delivery schedule. The Parties agree that during the course of the implementation, changes to the project schedule may be required. Any changes to the project schedule must be mutually agreed to by both Parties and such agreement shall not be unreasonably withheld.

- 3.6.2 ImageCast® X – This training introduces the ImageCast® X system with an emphasis on the operation of the hardware. Students can expect to learn general operations, logic and accuracy testing, Election Day setup and operation, and troubleshooting.
- 3.6.3 ImageCast® ICC – This training introduces the ImageCast® ICC with an emphasis on the operation of the hardware. Students can expect to learn general operations, logic and accuracy testing, ballot scanning operation, and troubleshooting.
- 3.6.4 EMS Server Installation, Configuration & Testing. Dominion will provide a minimum total of one (1) day of direct onsite support for EMS Server installation, configuration & testing.
- 3.6.5 Democracy Suite® EMS System– This training covers the restoring election project backups, creating ICX, ICC and ICXVA files, tally and reporting.
- 3.6.6 System Acceptance Testing Support. Dominion will provide direct onsite training and support during the System Acceptance Testing period.
- 3.6.7 Pollworker Train the Trainer – This provides training to the Customer staff on operations of a polling location including the ImageCast® X, ICX Card activation, testing and troubleshooting.
- 3.7 ***Election Ballot Definition Setup.*** Dominion shall provide election setup services and support for the election database creation and ballot review for 2 Elections. Ballot definition services will be provided in English and Spanish only and will include the following: Democracy Suite Election project setup, provide the Mail Ballot/Absentee PDF artwork, verification and proofing for each Election, provide audio setup for audio voting using a synthesizer. Any outside recording charges would be at the Customer's expense.
- 3.8 ***Travel and Expenses included.*** All costs of Dominion transportation, lodging and meal expenses are included during the Agreement Term.
- 3.9 ***Ongoing telephone support.*** Telephone support shall be available for Customers during the Term of the Agreement at no additional costs.
- 3.10 ***Other Services, Consumables or Equipment.*** Any other services, consumables or equipment not specifically identified in this Agreement are available for purchase by the Customer at the then current Dominion list price.

3.11 ***Disposal of Present Voting Systems.*** Dominion and County agree that Dominion shall dispose of the present voting machines possessed by the Customer at no cost to Customer and in accordance with HAVA specifications.


