BACKGROUND:

Summary

Westlaw is an online legal research platform with a variety of subscription tiers. The Office of the Public Defender uses Westlaw as a database to search case law, statutes and as a source of other legal information. The Office of the Public Defender requires a modification to their current Westlaw legal research subscription to add 20 more subscribers to their service, due to the addition of attorneys.

Impact on Residents and Businesses

The Public Defender's office expects no impact on private residents or private businesses.

Additional Fiscal Information

The total cost of this subscription is approximately \$7,029 monthly/\$84,348 annually, with a one percent (1%) annual increase. This is an additional increase of approximately \$8,981 yearly from the original contract. This is a 5-year subscription that started on August 27, 2021. The total increased amount will not exceed \$41,346.
