## BACKGROUND:

### **Summary**

The U.S. Department of Housing and Urban Development (HUD) requires that all substantial amendments to the County's Five-Year Consolidated Plan and the One-Year Action Plans are subject to the Citizen Participation Plan and approved by the Board of Supervisors and HUD. In accordance with the County of Riverside's Citizen Participation Plan for the 2019-2024 Five Year Consolidated Plan (Citizen Participation Plan), all new activities added to a One-Year Action Plan, any significant increases in funding or changes to an existing project, or other changes or amendments to the 2019-2024 Five-Year Consolidated Plan are considered to be substantial amendments.

The proposed Community Development Block Grant (CDBG) projects warranting these substantial amendments have been determined by staff to be eligible activities that meet a National Objective of the CDBG and ESG-CV programs. A description of the proposed amendments to the 2019-2020 One-Year Action Plan, the 2020-2021 One-Year Action Plan, and the 2022-2023 One-Year Action Plan are set forth in Attachments A, B, C, D, and E attached hereto. Staff recommends approval of the CDBG and ESG-CV projects listed below as substantial amendments to the 2019-2020 One-Year Action Plan, the 2020-2021 One-Year Action Plan, and the 2022-2023 One-Year Action Plan of the CDBG and ESG-CV projects listed below as substantial amendments to the 2019-2020 One-Year Action Plan, the 2020-2021 One-Year Action Plan, and the 2022-2023 One-Year Action Plan of the 2019-2024 Five Year Consolidated Plan.

Pursuant to the California Environmental Quality Act (CEQA), the Substantial Amendments were reviewed and determined to be categorically exempt from CEQA under State CEQA Guidelines Section 15061(b)(3), General Rule or "Common Sense" exemption. The Substantial Amendments are administrative planning documents that will only have financial and administrative effects. It can be seen with certainty that there is no possibility that the proposed Substantial Amendments may have a significant effect on the environment and will not lead to any direct or reasonably indirect physical impacts. The projects identified in the Substantial Amendments will be subject to separate CEQA environmental review prior to taking any choice limiting action or discretionary action on that specific project. A Notice of Exemption will be filed

by county staff with the County Clerk within five days of the approval of the Substantial Amendments.

Furthermore, the Substantial Amendments were determined to be exempt from the provisions of the National Environmental Policy Act (NEPA) pursuant to Title 24 Code of Federal Regulations Sections 58.34 (a)(1) and (a)(3) since the proposed Substantial Amendments are administrative activities. The projects identified in the Substantial Amendments will be subject to separate NEPA environmental review prior to taking any choice limiting action or discretionary action on that specific project.

Pursuant to 24 CFR Section 91.105 and the Citizen Participation Plan, the Housing and Workforce Solutions Department published the required public notice notifying the public of the comment period for the proposed substantial amendments on December 11, 2022.

County Counsel has reviewed and approved as to form the Substantial Amendments to the 2019-2020 One-Year Action Plan, the 2020-2021 One-Year Action Plan, and the 2022-2023 One-Year Action Plan of the 2019-2024 Five Year Consolidated Plan.

#### Impact on Residents and Businesses

**Good Hope Road Improvements:** The County of Riverside Transportation and Land Management Agency (TLMA) will use CDBG funds will be used to pay for costs associated with road improvement to Fisher Street (26' paved width) from Cox St. to the City of Perris boundary, in the unincorporated community of Good Hope, California. CDBG funds will provide access to low-income residents of the surrounding low-mod areas of the community.

**Mead Valley Road Improvements:** The County of Riverside Transportation and Land Management Agency (TLMA) will use CDBG funds will be used to pay for costs associated with road improvements to Burns Street (28' paved width) from Brown St. to Alexander St. in the unincorporated community of Mead Valley, California. CDBG funds will provide access to low-income residents of the surrounding low- mod areas of the community.

**Mecca Sports Park:** The County of Riverside will use CDBG funding to pay for predevelopment, design, and non-construction costs associated with the Mecca Sports Park in the unincorporated community of Mecca, California. Eligible CDBG activities will include fees, permits, project management, legal fees, inspections, and other expenses. The 6.7-acre facility will be located at Avenue 66 and Dale Kiler Road. The \$8 million park will include restrooms, snack bar, a jogging path, exercise equipment, covered picnic areas, sports fields, lighting, and public art.

**Community Enhancement Program:** As an extention to the County's CDBG-funded Code Enforcement activities, Riverside County HWS will use CDBG funds for community group-coordinated events and property clean-ups in eligible unincorporated areas within Riverside

County. Funds will be used for supplies, event outreach materials, salaries (direct costs), equipment cost, trash/debris removal, and project delivery costs.

**Operation Safe House Main Stay Shelter-Covid:** Operation Safehouse provides a 30-day emergency shelter for youth 18-24 at the Main Stay Transitional Living apartment complex to prevent the spread of COVID-19. There are two apartments dedicated to the emergency shelter to assist in stabilizing, counseling, and temporary housing. ESG-CV funds will be used for the cost of 24-hour Case Managers staff direct cost, and part-time Counselor staff direct cost, a new vehicle (SUV or Van) to assist with transportation of clients for emergency response, COVID testing, and staff/client social distancing safety.

### Additional Fiscal Information

There will be no impact upon the County's General Fund, the proposed projects will be fully funded with CDBG funds from the U.S. Department of Housing and Urban Development.
