

BACKGROUND:

Summary

By Minute Order 3.46 of July 26, 2022, the Board of Supervisors entered into a contract with Onyx Paving Company, Inc. of Anaheim, California for the construction of the Soboba Street Resurfacing Project to resurface approximately 1.2 miles of Soboba Street from Stetson Avenue to Florida Avenue (State Highway 74), in the Community of East Hemet of Riverside County.

The original authorized amount of the contract was \$1,268,000. The total value of work came in at \$1,160,284 which is 8.8% lower than the originally authorized amount. The reduction of the total cost was the result of using less quantities than anticipated to complete the work.

The work was completed in conformance with the plans and specifications and the contractor was granted relief of maintenance on October 31, 2022.

Impact on Residents and Businesses

The improvements benefit the project area by providing the public with a smooth paved roadway that will improve the safety and efficiency of vehicular traffic.

If the total pay quantity of any item of work required under the contract varies from the Engineer's Estimate by 25 percent or less, payment will be made for the quantity of work of said item performed at the contract unit price, unless eligible for adjustment pursuant to Section 9-1.15, "Work-Character Changes."

Contract History and Price Reasonableness

Five bids were received on May 4, 2022 ranging from \$1,272,000 to \$1,415,000. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsive and responsible bid was submitted by Onyx Paving Company, Inc. in the amount of \$1,272,000 which was \$99,332.80 (7.24%) lower than the Engineer's Estimate. The contract amount (\$1,268,000) varies from the bid amount (1,272,000) because Alternative Bid Schedule 1 in the amount of \$4,000 was not selected for award.
