

**BACKGROUND:**

**Summary**

By Minute Order 3.23 of May 10, 2022, the Board of Supervisors entered into a contract with Match Corporation of San Bernardino, California for the construction of the Thousand Palms Canyon Road Resurfacing Project to resurface approximately 4.2 miles from Ramon Road / Washington Street to Dillon Road, in the Community of Thousand Palms of Riverside County.

The original authorized amount of the contract was \$3,293,741. The total value of work came in at \$2,782,482 which is 15.5% lower than the originally authorized amount. The reduction of the total cost was the result of using less quantities than anticipated to complete the work.

The work was completed in conformance with the plans and specifications and the contractor was granted relief of maintenance on November 9, 2022.

**Impact on Residents and Businesses**

The improvements benefit the project area by providing the public with a smooth paved roadway that will improve the safety and efficiency of vehicular traffic.

If the total pay quantity of any item of work required under the contract varies from the Engineer's Estimate by 25 percent or less, payment will be made for the quantity of work of said item performed at the contract unit price, unless eligible for adjustment pursuant to Section 9-1.15, "Work-Character Changes."

**Contract History and Price Reasonableness**

Five bids were received on February 23, 2022 ranging from \$3,293,741 to \$4,212,247. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsive and responsible bid was submitted by Match Corporation in the amount of \$3,293,741 which was \$392,959 (11%) lower than the Engineer's Estimate.
