In her retirement from her city council and professional career, Doris Morgan continued to give back. She was an active member of the Riverside County Advisory Council on Aging, traveling to each meeting from Blythe to Moreno Valley and serving as an energetic advocate for seniors and individuals in need. She stepped up to help asylum seekers, greatly assisting the county and the Blythe community with the humanitarian response.

Doris recently stepped down from her service at the Palo Verde Cemetery District Board of Trustees, after serving 13 years.
